9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. Farmers Insurance Exchange filed a claim on September 7, 2018 against
11 the City and County of San Francisco. The claim involves alleged property damage arising
12 from a water main break. Pursuant to Administrative Code, Section 10.22, the Board of
13 Supervisors hereby authorizes the City Attorney to settle and compromise said claim by
14 payment of \$300,472.

15 Section 2. The source of funding herein appropriated for use by the San Francisco
16 Public Utilities Commission (SFPUC) for purposes of this settlement payment is the SFPUC
17 Water Enterprise fund balance.
