[Settlement of Lawsuit - Abuon Mayen - \$225,000 - Appropriation - Water Enterprise Fund Balance]

Ordinance authorizing settlement of the lawsuit filed by Abuon Mayen against the City and County of San Francisco for \$225,000; the lawsuit was filed on March 6, 2018, in San Francisco Superior Court, Case No. CGC-18-566751; entitled <u>Abuon Mayen v. City and County of San Francisco, et al.</u>; the lawsuit involves alleged personal injury from a vehicle collision; and appropriating \$225,000 from the San Francisco Public Utilities Commission Water Enterprise fund balance for payment of settlement.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Abuon Mayen v. City and County of San Francisco</u>, et al., San Francisco Superior Court, Case No. CGC-18-566751 by the payment of \$225,000. The lawsuit involves alleged personal injury from a vehicle collision.

Section 2. The above-named action was filed in San Francisco Superior Court on March 6, 2018, and the following parties were named in the lawsuit: plaintiff: Abuon Mayen; defendants: City and County of San Francisco and Michael Spillane.

Section 3. The source of funding herein appropriated for use by the San Francisco Public Utilities Commission (SFPUC) for purposes of this settlement payment is the SFPUC Water Enterprise fund balance.
