

Queens SF, LLC located at 1235 9th Avenue San Francisco, CA 94122 is requesting a determination for Public Convenience of Necessity (PCN) for our type 20 ABC license (person to person and premise to premise transfer). Our business hours are Mondays and Tuesdays (8am to 4 pm) and Wednesdays thru Sundays (8am to 8 pm).

We filed the application for the type 20 license on August 8th, 2019 at the ABC office on 33 New Montgomery Street, San Francisco, CA 94105. We posted our Public Notice on August 12th, 2019 and mailed out our 500 foot radius mailings on August 23rd, 2019.

Queens SF, LLC is a Korean superette (a specialty market and deli). We are hoping to introduce and educate the local neighborhood and greater S.F. community of the vastness and depth of the different varieties of traditional Korean rice wines. There are various stores around the city that carry large commercial brand rice wines, but our hope is to introduce smaller producers who share the same values as we do. We would be the first store in San Francisco to carry such brands and varieties.
