Ordinance authorizing settlement of the lawsuit filed by The Roman Catholic Archbishop of San Francisco, et al. against the City and County of San Francisco for payment of \$913,970 by U.S. Pipe & Foundry Company to the City; the lawsuit was filed on April 11, 2013, in United States District, Case No. 13-cv-2220 MEJ; entitled <a href="https://doi.org/10.103/j.cv/nc-2220">The Roman Catholic Archbishop of San Francisco, et al. v. City and County of San Francisco, et al.; the lawsuit involves dangerous condition of public property and inverse condemnation.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>The Roman Catholic Archbishop of San Francisco</u>, et al. v. City and County of San Francisco, et al., United States District Court, Case No. 13-cv-2220 MEJ by the payment of \$913,970 by U.S. Pipe & Foundry Company. The lawsuit involves dangerous condition of public property and inverse condemnation.
