[Settlement of Lawsuit - Kai Kopp - \$40,000]

Ordinance authorizing settlement of the lawsuit filed by Kai Kopp against the City and County of San Francisco for \$40,000; the lawsuit was filed on March 28, 2016, in San Francisco Superior Court Case No. CGC-16-551183; entitled <u>Kai Kopp v. City and</u> <u>County of San Francisco, et al.</u>; the lawsuit involves an alleged personal injury in a City park.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Kai Kopp v. City and County of San Francisco, et al.</u>, San Francisco Superior Court Case No. CGC-16-551183 by the payment of \$40,000. The lawsuit involves an alleged personal injury in a City park.
