Resolution Commemorating the 40<sup>th</sup> Anniversary of the Occupation of Alcatraz Island November 20, 1969 to June 11, 1971.



WHEREAS, The occupation was initiated and lead primarily by "Indians of all Tribes", made up of California Indian and other Native American students from California Universities and colleges, including Richard Oakes and others from San Francisco State University; and,


