

[Settlement of Lawsuit - Lu Xia Tan Chen - \$50,000]

Ordinance authorizing settlement of the lawsuit filed by Lu Xia Tan Chen against the City and County of San Francisco for \$50,000; the lawsuit was filed on April 19, 2018, in San Francisco Superior Court, Case No. CGC-18-565891; entitled <u>Lu Xia Tan Chen v.</u> <u>City and County of San Francisco</u>; the lawsuit involves alleged injuries when plaintiff was struck in a crosswalk.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Lu Xia Tan Chen v. City and County of <u>San Francisco</u>, San Francisco Superior Court, Case No. CGC-18-565891 by the payment of \$50,000. The lawsuit involves alleged injuries when plaintiff was struck in a crosswalk by a Department of Public Works truck.
