

1 [Liquor License Transfer - 32-3rd Street - Night Market]

3 **Resolution determining that the premise-to-premise transfer of a Type-48 on-sale**
4 **general public premises liquor license to 32 3rd Street L-PSHIP, doing business**
5 **as Night Market located at 32-3rd Street (District 6), will serve the public**
6 **convenience or necessity of the City and County of San Francisco; and**
7 **requesting that the California Department of Alcoholic Beverage Control impose**
8 **conditions on the issuance of the license.**

10 WHEREAS, 32 3rd Street L-PSHIP is seeking the premise-to-premise transfer of
11 a Type-48 on-sale general public premises liquor license to do business as Night
12 Market located at 32-3rd Street (District 6); and

13 WHEREAS, The Planning Department has verified that the area is properly
14 zoned and recommends approval; and

15 WHEREAS, The Police Department has filed eighteen protests and thirty eight
16 letters of support with the Department of Alcoholic Beverage Control under California
17 Business and Professions Code, Section 24013, and recommends that the Department
18 of Alcoholic Beverage Control issue the liquor license with conditions; and

19 WHEREAS, The conditions recommended by the Police Department are the
20 following: 1) Sales, service and consumption of alcoholic beverages shall be permitted
21 only between the hours of 3:00 p.m. and 2:00 a.m. each day of the week; 2) The sale of
22 alcoholic beverages for consumption off the premises is prohibited; 3) No noise shall be
23 audible at any nearby residence; and 4) Petitioner(s) shall actively monitor the area
24 under their control in an effort to prevent the loitering of persons on any property
25 adjacent to the licensed premises as depicted on ABC-253; now, therefore, be it

1 RESOLVED, That in accordance with California Business and Professions Code,
2 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
3 hereby determines that the premise-to-premise transfer of a Type-48 on-sale general
4 public premises liquor license to 32 3rd Street L-PSHIP, doing business as Night Market
5 located at 32-3rd Street, will serve the public convenience or necessity of the City and
6 County of San Francisco; and, be it

7 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
8 San Francisco hereby endorses and adopts the recommendations of the Police
9 Department listed above and recommends that the Department of Alcoholic Beverage
10 Control issue the license with those conditions.
