Seat 4, succeeding Charles Perl, term expiring June 5, 2017, must be the County Treasurer; the County Controller; a representative appointed by the Board of Supervisors; the County Superintendent of Schools or his/her designee; the Chancellor of the Community College District or his/her designee; or a member of the public: a majority of which shall have expertise in, or an academic background in, public finance and the combination of whom shall be economically diverse and bipartisan in political registration, for the unexpired portion of a four-year term ending June 5, 2021. Seat 5, succeeding Aimee Brown, term expiring June 5, 2017, must be the County Treasurer; the County Controller; a representative appointed by the Board of Supervisors; the County Superintendent of Schools or his/her designee; the Chancellor of the Community College District or his/her designee; or a member of the public: a majority of which shall have expertise in, or an academic background in, public finance and the combination of whom shall be economically diverse and bipartisan in political registration, for the unexpired portion of a four-year term ending June 5, 2021.

## Additional Conditions for Membership:

- All members of the five-member Committee are nominated by the Treasurer and confirmed by and serve at the pleasure of the Board of Supervisors.
- A member may not be employed by an entity that had contributed to a reelection campaign of the County Treasurer or a member of the Board of Supervisors in the previous three years.
- A member may not directly or indirectly raise money for the County Treasurer or a member of the Board of Supervisors, while a member of the Committee.
- A member may not secure employment with bond underwriters, bond counsel, security brokerages or dealers, or with financial service firms for three years after leaving the Committee.
