Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>City and County of San Francisco, et al. v. Fidelis Cybersecurity, Inc., et al.</u>, San Francisco Superior Court, Case No. CGC-18-571572, by the payment of \$850,978 over 18 months by Fidelis Cybersecurity, Inc. to the City and by the City's return of hardware purchased from Fidelis Cybersecurity, Inc. The lawsuit involves the sale of products and services to the City by Fidelis in violation of conflict of interest laws.

Section 2. The above-named action was filed in San Francisco Superior Court on November 27, 2018, and the following parties were named in the lawsuit: plaintiffs City and County of San Francisco and People of the State of California and defendants Fidelis Cybersecurity Inc.; Maarek Zalatimo (aka Mark Zalatimo); Heather Zalatimo; Jeff Jorgenson; and Does One through Ten.
