Employed under RAMS, the Division of Peer-Based Services offers culturally congruent peer counseling & support, outreach, resource linkage, and education & training throughout San Francisco to clients of Behavior Health Services. As Program Manager I actively engaged in workforce & professional development supervising 30 peer counselors, as well as engage with clients through outreach efforts to SFBHS & DPH agencies and community partners. I advocate and work with those who are seeking help navigating the system of care, folks experiencing homelessness, marginalized communities with barriers to health care and connect with those who are incarcerated by doing jail visits. Along with RAMS, the Peer Wellness Center Team and I work with clients in support of their wellness and recovery with an approach that is strengths-based and promotes a sense of empowerment, self- direction, and hope. To add, I am currently pursuing my education towards becoming a Paramedic.

I would like to begin by thank the rules committee supervisors, Supervisor Hillary Ronen, Supervisor Shaman Walton, and Supervisor Gordon Mar for allowing me to be in this meeting today. I want to thank Victor Young, Board of Supervisors; Erin Mundy Legislative Aid from the office of Supervisor Rafael Meandelman; and Angelica Almeida from the Forensic/Justice Involved Behavioral Health Services for making time to contacting me and assisting with my participation in the Housing Conservatorship Working Group.

I also want to thank Mayor London Breed as well as Senator Weiner for working to pass SB 1045 at the state level. I want to thank the San Francisco Department of Public Health and the Office of the Conservator for both working in the State legislature on SB 1045 on local planning and implementation work here in San Francisco.

In San Francisco, we have those in our community who are dual diagnosed both with mental health conditions and substance use that need care and special attention. I recognize that the growing challenge for our public health system, which acknowledges the crippling impacts of substance abuse and use on a growing number of people who are unhoused and experiencing homelessness are suffering from untreated mental illness.

With the implementation of SB 1045 in San Francisco it will allow Office of the Public Conservator to be appointed custodians proving wrap around care, supportive services, treatment and management of the individual's affair for the duration of the conservatorship. I understand that those under SB 1045 are those suffering from serious mental health disorders and substance use disorders and have been placed in involuntary psychiatric 5150 hold at least eight times in the prior year. These folks keep returning to PES over and over again. I meet with these same individuals who share that they have just been released from hospital emergency rooms, jails, being back in the streets, or share stories of people, family and friend who passed away from an overdose or illness.

I am honored and appreciate being given the opportunity to be part of the Housing Conservatorship Working Group. The SB 1045 gives us an opportunity to interrupt the vicious spinning of the revolving door of the sick and addiction by employing a public health response within a legal framework.

I was looking and reading what Rafael Mandelman shared in his social media post and strongly agree with him that "even we only reach a handful of folks, I believe we must try to get care to those hardest-to-reach people, the very sickest and those who are likely to voluntarily seek help."

As I continue my work and serving those needing help and seeking to work on their recovery. I am hopeful that this program will be an essential tool and support those under Housing Conservatorship Working Group.

I also have worked at Kaiser in the Psychiatric Call Center which afforded me first hand knowledge of the limitations within their HMO network of care. Additionally I have served as an adjunct and clinical professor with Samuel Merritt University teaching in the classroom and at clinical sites, as well as having served as a preceptor on numerous occasions to nursing students, medical residents, and other licensed professionals working on advance practice degrees while I worked in PES.

I am a member of the board of JYCA, the Jewish Youth for Community Action, a member of Stonewall Democratic Club and the SEIU Committee for Political Education in both Alameda County and San Francisco County. - I am 20 year resident of San Francisco's Mission District. I am a queer, 49 year-old, Jewish woman. I work in homeless services and currently work and serve low income residents of the Tenderloin neighborhood. I am also the family member of an uncle who lives with chronic, severe mental illness, who has been in varying levels of mandated care over his lifetime.
- 2. Professional Experience: I have over 20 years of professional experience advocating on behalf of and providing services to low income individuals and communities. I have worked in non-profit, community-based organizations in the areas of affordable housing, tenant's rights, and homelessness. My direct work with clients has primarily been with residents of SROs, Public Housing and Section 8 renters and people experiencing homelessness. I spent three years coordinating a multi-disciplinary homeless outreach team on LA's Skid Row, where I became intimately familiar with the issues of chronic mental illness among those living on the streets. Along with our team's mental health clinicians and outreach staff from the Department of Mental Health, we addressed many cases of severe and persistent mental illness where we utilized the County's mental health system of care, including the 5150 process, the Assisted Outpatient Program and the office of Conservator. Currently, I work for Community Housing Partnership, which is a supportive housing provider that provides homes and services to people experiencing homelessness. CHP has 1700 units of affordable housing, many of which are SROs in the Tenderloin and the Central City and includes family housing on Treasure Island and a Navigation Center at the Civic Center Hotel. I have a Master's in Social Work (MSW) degree from San Francisco State University.

SEC. 5.37-1. ESTABLISHMENT OF WORKING GROUP.

There is hereby established the Housing Conservatorship Working Group (the "Working Group") of the City and County of San Francisco.

(Added by Ord. 108-19, File No. 181042, App. 6/21/2019, Eff. 7/22/2019)

SEC. 5.37-2. MEMBERSHIP.

The Working Group shall be comprised of 12 members, appointed as follows:

(a) Seats 1 and 2 shall be held by representatives of disability rights advocacy groups, appointed by the Mayor and the Board of Supervisors, respectively.

(b) Seats 3 and 4 shall be held by representatives of labor unions, appointed by the Mayor and the Board of Supervisors, respectively.

(c) Seats 5 and 6 shall be held by representatives of organizations providing direct services to homeless individuals or families, appointed by the Mayor and the Board of Supervisors, respectively.

(d) Seat 7 shall be held by an employee of a hospital located in San Francisco with experience in mental health and substance use disorders, appointed by the Director of Health.

(e) Seat 8 shall be held by an employee of the Behavioral Health Services program of the Department of Public Health, appointed by the Director of Health.

(f) Seat 9 shall be held by an employee of the Department of Public Health, appointed by the Director of Health.

(g) Seat 10 shall be held by an employee of the Human Services Agency, appointed by the Director of the Human Services Agency.

(h) Seat 11 shall be held by an employee of the Department of Homelessness and Supportive Housing, appointed by the Director of the Department of Homelessness and Supportive Housing.

(i) Seat 12 shall be held by an employee of the San Francisco Police Department, appointed by the Chief of Police.

(Added by Ord. <u>108-19</u>, File No. 181042, App. 6/21/2019, Eff. 7/22/2019)

SEC. 5.37-3. ORGANIZATION AND TERMS OF OFFICE.

(a) Members of the Working Group shall serve at the pleasure of their respective appointing authorities, and may be removed by the appointing authority at any time.

(b) Appointing authorities shall make initial appointments to the Working Group by no later than 90 days after the effective date of this Article XXXVII.

(c) The Working Group shall hold its inaugural meeting not more than 30 days after a quorum of the Working Group, defined as a majority of seats, has been appointed. Thereafter, the Working Group shall meet at least once every four months until the sunset date in Section 5.37-5.

(d) Members of the Working Group shall receive no compensation from the City, except that the members in Seats 8, 9, 10, 11, and 12 who are City employees may receive their respective City salaries for time spent working on the Working Group.

(e) Any member who misses three regular meetings of the Working Group within any 12month period without the express approval of the Working Group at or before each missed meeting shall be deemed to have resigned from the Working Group 10 days after the third unapproved absence. The Working Group shall inform the appointing authority of any such resignation.

(f) The Department of Public Health shall provide administrative and clerical support for the Working Group, and the Controller's Office shall provide technical support and policy analysis for the Working Group upon request. All City officials and agencies shall cooperate with the Working Group in the performance of its functions.

(Added by Ord. <u>108-19</u>, File No. 181042, App. 6/21/2019, Eff. 7/22/2019) SEC. 5.37-4. DUTIES.

(a) The Working Group shall conduct an evaluation of the effectiveness of the implementation of Chapter 5 (commencing with Section 5450) of the California Welfare and Institutions Code ("Chapter 5") in addressing the needs of persons with serious mental illness and substance use disorders in the City. The evaluation shall include: 1) an assessment of the number and status of persons who have been recommended for a Housing Conservatorship, evaluated for eligibility for a Housing Conservatorship, and/or conserved under Chapter 5; 2) the effectiveness of these conservatorships in addressing the short- and long-term needs of those persons, including a description of the services they received; 3) the impact of conservatorships established pursuant to Chapter 5 on existing conservatorships established pursuant to Division 4 (commencing with Section 1400) of the California Probate Code or Chapter 3 (commencing with Section 5350) of the California Welfare and Institutions Code, and on mental health programs provided by the City; 4) the number of detentions for evaluation and treatment under Section 5150 of the California Welfare and Institutions Code that occurred in San Francisco during the evaluation period, broken down by the type of authorized person who performed the detention (e.g., peace officer or designated member of a mobile crisis team); and 5) where a detention for evaluation and treatment under Section 5150 was performed by a peace officer, an explanation as to why the peace officer was the appropriate person to perform the detention.

(b) The Working Group shall prepare and submit reports to the Mayor, the Board of Supervisors, and the Legislature on its findings and recommendations regarding the implementation of Chapter 5.

(1) **Reports to the Mayor and Board of Supervisors.** The Working Group shall submit its first report to the Mayor and the Board of Supervisors by no later than six months after the effective date of the ordinance in Board File No. 181042 establishing Division IV of <u>Article 41</u> of the Health Code, and annually thereafter.

(2) **Reports to the Legislature.** A preliminary report shall be submitted to the Legislature by no later than January 1, 2021, in compliance with Section 9795 of the California Government. Code. A final report shall be submitted to the Legislature by no later than January 1, 2023, in compliance with Section 9795 of the California Government Code.

Unless the Board of Supervisors by ordinance extends the term of the Working Group, this Article XXXVII shall expire by operation of law, and the Working Group shall terminate, on December 31, 2023. In that event, after that date, the City Attorney shall cause this Article XXXVII to be removed from the Administrative Code.
