

Ordinance authorizing settlement of the lawsuit filed by Cheryl Jarne against the City and County of San Francisco for \$40,000; the lawsuit was filed on March 2, 2018, in San Francisco Superior Court, Case No. CGC-18-564726; entitled <u>Cheryl Jarne v. City and</u> <u>County of San Francisco, et al.</u>; the lawsuit involves an alleged personal injury on a City sidewalk.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Cheryl Jarne v. City and County of</u> <u>San Francisco, et al.</u>, San Francisco Superior Court, Case No. CGC-18-564726 by the payment of \$40,000. The lawsuit involves an alleged personal injury on a City sidewalk.
