[Administrative Code - Extension of Pedestrian Safety Advisory Committee]

Ordinance amending the Administrative Code to extend the sunset date for the Pedestrian Safety Advisory Committee by one year, to October 1, 2020, and requiring the Committee to recommend changes to its structure and duties.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Article IV of Chapter 5 of the Administrative Code is hereby amended by revising Sections 5.4-2 and 5.4-3, to read as follows:

SEC. 5.4-2. DUTIES OF THE COMMITTEE.

By no later than May 1, 2020, the Advisory Committee shall submit to the Board of Supervisors a report recommending possible changes to the structure, duties, or member qualifications of the Advisory Committee.

SEC. 5.4-3. SUNSET.

Unless the Board of Supervisors by ordinance extends the term of the Advisory Committee, this Article IV shall expire by operation of law, and the Advisory Committee shall terminate, on October 1, 20192020. After that date, the City Attorney shall cause this Article to be removed from the Administrative Code.

Section 2. Effective Date; Retroactivity.

- (a) This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.
- (b) This ordinance shall be retroactive to October 1, 2019. It is the intent of the Board of Supervisors that, during the period between October 1, 2019 and the effective date of this ordinance, the Advisory Committee shall continue to operate without interruption, and that the incumbent members of the Advisory Committee shall continue to hold their seats without reappointment unless displaced or removed in accordance with Section 5.4-1 of the Administrative Code.

Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal Code that are explicitly shown in this ordinance as additions, deletions, Board amendment additions, and Board amendment deletions in accordance with the "Note" that appears under the official title of the ordinance.
