Overview of SOGI Data Collection:

- July 1, 2017: expanded SOGI data collection to all client-based programs and services, and modified standards to be consistent with DPH standards, in compliance with the SOGI ordinance
- All demographic data collections forms and applications for all client-based programs and services updated
- All database and storage systems for client-based programs and services updated
- Plan for adding fields for chosen name and gender pronouns for FY2020-2021

 - All MOHCD managers completed DHR implicit bias training
 - Funded a trans community group to provide cultural humility training for housing providers

Addressing Underrepresentation FY18-19 & Beyond

- Steps taken in FY2018-19 or steps planned for future years, to address underrepresentation of LGBTQ+ clients in direct services and programs operated by, or funded by, Department
 - Continue to support LGBTQ+-focused programs and services
 - Continue to ensure that general (non-LGBTQ+-focused) programs and services are accessible to LGBTQ+ community through outreach and cultural humility training
 - Improve accessibility of general programs and services for transgender and gender non-conforming community, with particular focus on housing
 - Establish a rental subsidy program supporting permanent and transitional housing opportunities for transgender and gender non-conforming individuals
 - Improve SOGI data collection by educating and training staff, clients, grantees and partner organizations
