17	(a)	Pursuant to Charter Section D3.750-5, the Building Inspection Commission

- (b) Chapter 11D of the Building Code requires the owner of an existing building with a place of public accommodation to have the building inspected for compliance with accessible entry and path of travel requirements. If the building is not in compliance, the owner must either bring the building into compliance or obtain a finding from the City of equivalent facilitation, technical infeasibility, or unreasonable hardship. Table 1107D sets forth deadlines for the four compliance categories to submit specified information to DBI, file an application for any required building permits, and obtain the required building permits. All

mandated work must be completed within the time periods specified in the Building Code for
building permits unless an extension of time is granted pursuant to Section 1108D.

(c) Under the Building Code, property owners are responsible for compliance with Code requirements notwithstanding any leases that may shift some of the burden of compliance onto the tenants. Many, if not all, of the buildings subject to the Chapter 11D requirements have multiple leased spaces many of which are operated by small businesses without a lot of financial resources. This ordinance will extend for an additional six months all compliance deadlines to resolve compliance issues for those owners who missed past deadlines and to give building owners and tenants more time to resolve any compliance issues going forward.

SECTION 1108D - EXTENSIONS OF TIME

(a) For good cause shown, the Building Official may grant one extension of time for up to six months from the compliance timelines in Table 1107D. For good cause shown, one or more additional extensions of time may be granted by the Access Appeals Commission pursuant to Section 1110D; provided, however, that in no event shall the Commission extend the time to complete the mandatory work required by this Chapter 11D beyond *December June* 1, 2023 2024. The Commission's decision shall be final.
