13 of \$50,000. The lawsuit involves alleged injuries when plaintiff was struck in a crosswalk by a
14 Department of Public Works truck.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 April 19, 2018, and the following parties were named in the lawsuit: Plaintiff: Lu Xia Tan




