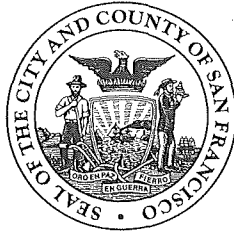

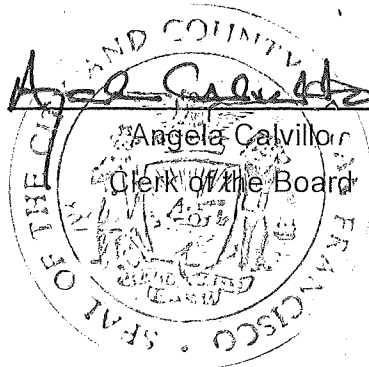

12 introduced two Articles of Impeachment against President Donald J. Trump, wherein he is

14 WHEREAS, In his conduct of the office of President of the United States - and in
15 violation of his constitutional oath faithfully to execute the office of President of the United
16 States and, to the best of his ability, preserve, protect, and defend the Constitution of the


