1 [Declaring Results of Special Election - Special Tax District No. 2019-2 (Pier 70 Leased  
2 Properties)]

3 **Resolution declaring the results of the special election and directing recordation of the**  
4 **notice of special tax lien for the City and County of San Francisco Special Tax District**  
5 **No. 2019-2 (Pier 70 Leased Properties); and determining other matters in connection**  
6 **therewith, as defined herein.**

7  
8 WHEREAS, California Statutes of 1968, Chapter 1333 ("Burton Act") and San  
9 Francisco Charter, Section 4.114 and Appendix B, beginning at Section B3.581, empower the  
10 City and County of San Francisco ("City"), acting through the San Francisco Port Commission  
11 ("Port" or "Port Commission"), with the power and duty to use, conduct, operate, maintain,  
12 manage, regulate, and control the lands within Port jurisdiction; and

13 WHEREAS, FC Pier 70, LLC, a Delaware limited liability company ("Master  
14 Developer") and the City, acting by and through the Port, are parties to a Disposition and  
15 Development Agreement (as amended from time to time, "DDA"), including a Financing Plan  
16 (as amended from time to time, "Financing Plan"), that governs the disposition and  
17 development of approximately 28 acres of land in the waterfront area of the City known as  
18 Pier 70 ("Project Site"); and

19 WHEREAS, In the general election held on November 4, 2014, an initiative entitled, the  
20 "Union Iron Works Historic District Housing, Waterfront Parks, Jobs and Preservation  
21 Initiative" ("Proposition F"), was approved by the voters in the City; and

22 WHEREAS, The DDA contemplates a project ("Project") under which the Port would  
23 initially lease the Project Site to the Master Developer for infrastructure development, and,  
24 ultimately, lease and sell parcels in the Project Site to vertical developers, for development of  
25 a mixed-use project described in the DDA; and

1           WHEREAS, The City anticipates that, in addition to the infrastructure and private  
2 development described above, future improvements will be necessary to ensure that the  
3 shoreline, public facilities, and public access improvements will be protected should sea level  
4 rise in the vicinity of the Project Site, and the Board of Supervisors of the City ("Board")  
5 desires to provide a mechanism to pay for the costs of such improvements; and

6           WHEREAS, At its hearing on August 24, 2017, and prior to recommending proposed  
7 Planning Code amendments for approval, by Motion No. 19976, the Planning Commission  
8 certified a Final Environmental Impact Report ("FEIR") for the Project (Case No. 2014-  
9 001272ENV) pursuant to the California Environmental Quality Act ("CEQA") (California Public  
10 Resources Code, Section 21000 et seq.), the CEQA Guidelines (14 Cal. Code Reg., Section  
11 15000 et seq.), and Chapter 31 of the Administrative Code; a copy of said Motion is on file  
12 with the Clerk of the Board in File No. 170930, and is incorporated herein by reference; and

13           WHEREAS, In recommending the proposed Planning Code amendments for approval  
14 by this Board at its hearing on August 24, 2017, by Motion No. 19977, the Planning  
15 Commission also adopted findings under CEQA, including a statement of overriding  
16 consideration, and a Mitigation Monitoring and Reporting Program ("MMRP"); a copy of said  
17 Motion and MMRP are on file with the Clerk of the Board in File No. 170930, and is  
18 incorporated herein by reference; and

19           WHEREAS, Under Chapter 43, Article X of the San Francisco Administrative Code (as  
20 it may be amended from time to time, "Code"), which Code incorporates by reference the  
21 Mello-Roos Community Facilities Act of 1982, as amended ("Mello-Roos Act"), this Board is  
22 authorized to establish a special tax district and to act as the legislative body for a special tax  
23 district; and

24       ///

1           WHEREAS, On January 14, 2020, this Board adopted a resolution (which resolution  
2 was signed by the Mayor on \_\_\_\_\_, 2020) entitled "Resolution of formation of City and  
3 County of San Francisco Special Tax District No. 2019-2 (Pier 70 Leased Properties) and a  
4 Future Annexation Area; determining other matters in connection therewith, as defined herein;  
5 and making findings under the California Environmental Quality Act" ("Resolution of  
6 Formation"), ordering the formation of the "City and County of San Francisco Special Tax  
7 District No. 2019-2 (Pier 70 Leased Properties)" ("Special Tax District") and a future  
8 annexation area, authorizing the levy of special taxes on property within the Special Tax  
9 District and preliminarily establishing an appropriations limit for the Special Tax District, all  
10 pursuant to the Code; and

11           WHEREAS, In the Resolution of Formation, this Board made certain findings under  
12 CEQA about the FEIR for the disposition and development of the Project Site, and those  
13 findings are incorporated in this Resolution as if set forth in their entirety herein; and

14           WHEREAS, On January 14, 2020, this Board also adopted a resolution (which  
15 resolution was signed by the Mayor on \_\_\_\_\_, 2020) entitled "Resolution determining  
16 necessity to incur bonded indebtedness and other debt in an aggregate principal amount not  
17 to exceed \$1,841,600,000 for the City and County of San Francisco Special Tax District No.  
18 2019-2 (Pier 70 Leased Properties) and determining other matters in connection therewith, as  
19 defined herein" ("Resolution Determining Necessity"), determining the necessity to incur  
20 bonded indebtedness and other debt (as defined in the Mello-Roos Act) in one or more series  
21 in the maximum aggregate principal amount of \$1,841,600,000 (to be calculated as set forth  
22 therein) upon the security of certain special taxes to be levied within the Special Tax District  
23 pursuant to the Code; and

24           WHEREAS, Under the provisions of the Resolution of Formation and the Resolution  
25 Determining Necessity and pursuant to a "Resolution calling special election in City and

1 County of San Francisco Special Tax District No. 2019-2 (Pier 70 Leased Properties) and  
2 determining other matters in connection therewith, as defined herein" (the "Election  
3 Resolution") heretofore adopted by this Board, the propositions of the levy of the special  
4 taxes, the establishment of the appropriations limit, and the incurring of bonded indebtedness  
5 and other debt were submitted to the qualified electors of the Special Tax District as required  
6 by the provisions of the Code; and

7 WHEREAS, Pursuant to the terms of the Election Resolution, which are by this  
8 reference incorporated herein, the special election has been held and the Clerk of the Board  
9 has on file a Canvass and Statement of Results of Election, (the "Canvass") a copy of which is  
10 attached hereto as Exhibit A; and

11 WHEREAS, This Board has reviewed the Canvass, finds it appropriate and wishes to  
12 complete its proceedings for the Special Tax District; now, therefore, be it

13 RESOLVED, That the foregoing recitals are all true and correct; and, be it

14 FURTHER RESOLVED, That the issues presented at the special election were the levy  
15 of special taxes within the Special Tax District, the incurring of bonded indebtedness and  
16 other debt in the maximum aggregate principal amount of \$1,841,600,000 and the  
17 establishment of an annual appropriations limit of not to exceed \$1,841,600,000 all pursuant  
18 to the Resolution of Formation and the Resolution of Necessity; and, be it

19 FURTHER RESOLVED, That the Board hereby approves the Canvass and finds that it  
20 shall be a permanent part of the record of its proceedings for the Special Tax District.

21 Pursuant to the Canvass, the issues presented at the special election were approved by the  
22 qualified electors of the Special Tax District by two-thirds (2/3) or more of the votes cast at the  
23 special election; and, be it

24 FURTHER RESOLVED, That pursuant to the voter approval, the Special Tax District is  
25 hereby declared to be fully formed with the authority to levy the special taxes, to incur the

1 approved bonded indebtedness and other debt and to have the established appropriations  
2 limit, all as heretofore provided in these proceedings and in the Code; it is hereby found that  
3 all prior proceedings and actions taken by this Board with respect to the Special Tax District  
4 were valid and in conformity with the Code; and, be it

5 FURTHER RESOLVED, That the Clerk of the Board is hereby directed to complete,  
6 execute and cause to be recorded in the Office of the Assessor-Recorder a notice of special  
7 tax lien in the form required by the Code, such recording to occur no later than fifteen (15)  
8 days following adoption by the Board of this Resolution; and, be it

9 FURTHER RESOLVED, That if any section, subsection, sentence, clause, phrase, or  
10 word of this Resolution, or any application thereof to any person or circumstance, is held to be  
11 invalid or unconstitutional by a decision of a court of competent jurisdiction, such decision  
12 shall not affect the validity of the remaining portions or applications of this Resolution, this  
13 Board hereby declaring that it would have passed this Resolution and each and every section,  
14 subsection, sentence, clause, phrase, and word not declared invalid or unconstitutional  
15 without regard to whether any other portion of this Resolution or application thereof would be  
16 subsequently declared invalid or unconstitutional; and, be it

17 FURTHER RESOLVED, That the Mayor, the Controller, the Director, Department of  
18 Elections, the Director of the Office of Public Finance, the Clerk of the Board and any and all  
19 other officers of the City are hereby authorized, for and in the name of and on behalf of the  
20 City, to do any and all things and take any and all actions, including execution and delivery of  
21 any and all documents, assignments, certificates, requisitions, agreements, notices, consents,  
22 instruments of conveyance, warrants and documents, which they, or any of them, may deem  
23 necessary or advisable in order to effectuate the purposes of this Resolution; provided  
24 however that any such actions be solely intended to further the purposes of this Resolution,  
25 and are subject in all respects to the terms of the Resolution; and, be it

1 FURTHER RESOLVED, That all actions authorized and directed by this Resolution,  
2 consistent with any documents presented herein, and heretofore taken are hereby ratified,  
3 approved and confirmed by this Board; and, be it

4 FURTHER RESOLVED, That this Resolution shall take effect upon its adoption.

 6 thereafter); (ii) establish an annual appropriations limit for  
 7 the Special Tax District in the amount of \$1,841,600,000;  
 8 and (iii) issue bonds in one or more series for the Special  
 9 Tax District in the maximum aggregate principal amount of  
 10 \$1,841,600,000 (calculated in accordance with the  
 11 resolution of the Board of Supervisors declaring the  
 12 necessity for such bonds), with interest at a rate or rates not
