

[Settlement of Lawsuit - Luz de Verano Cervantes - \$49,500]

Ordinance authorizing settlement of the lawsuit filed by Luz de Verano Cervantes against the City and County of San Francisco for \$49,500; the lawsuit was filed on May 16, 2018, in San Francisco Superior Court, Case No. CGC-18-566598; entitled <u>Luz</u> <u>de Verano Cervantes v. City and County of San Francisco, et al.</u>; the lawsuit involves alleged personal injury from a motor vehicle collision.

Be it ordained by the People of the City and County of San Francisco:
