

#### ORDINANCE NO.

[California Code of Civil Procedure, Section 998 - Offer to Compromise Litigation - Kellan Dunn - \$45,000]

Ordinance authorizing the service of an Offer to Compromise under Code of Civil Procedure, Section 998, in the lawsuit filed by Kellan Dunn against the City and County of San Francisco, to include a payment from the City and County of San Francisco of up to \$45,000 plus reasonable attorneys' fees and costs to be determined by the Court; the lawsuit was filed on May 9, 2018, in San Francisco Superior Court, Case No. CGC-18-566427; entitled <u>Kellan Dunn v. City and County of San Francisco, et al.</u>; the lawsuit involves an employment dispute.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to make an Offer to Compromise under Code of Civil Procedure Section 998 in the action entitled <u>Kellan Dunn v. City and County of San Francisco, et al.</u>, San Francisco Superior Court, Case No. CGC-18-566427 by the payment of up to \$45,000, plus reasonable attorneys' fees and costs to be determined by the Court. The lawsuit involves an employment dispute.

Section 2. The above-named action was filed in San Francisco Superior Court on May 9, 2018, and the following parties were named in the lawsuit: Plaintiff: Kellan Dunn; Defendants City and County of San Francisco, Fine Arts Museums of San Francisco, and Corporation of Fine Arts Museums.
