Ordinance authorizing settlement of the lawsuit filed by Tureko Straughter and K.R., a minor, against the City and County of San Francisco for \$160,000; the lawsuit was filed on August 22, 2018, in the United States District Court, Case No. 18-cv-03651; entitled <u>Tureko Straughter, individually and as the guardian for minor K.R.; and K.R.,</u> a minor, by and through his guardian Tureko Straughter; the lawsuit involves alleged civil rights violations.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Tureko Straughter, individually and as</u> the guardian for minor K.R.; and K.R., a minor, by and through his guardian <u>Tureko</u> <u>Straughter</u>, United States District Court, Case No. 18-cv-03651, by the payment of \$160,000. The lawsuit involves alleged civil rights violations.

Section 2. The above-named action was filed in United States District Court on August 22, 2018, and the following parties were named in the lawsuit: Plaintiffs: Tureko Straughter, and K.R., a minor; Defendants: City and County of San Francisco, Allen Nance, Samuel Nwigwe, Toni Powell, Roger Gainey, and Karen Sanchez.
