Ordinance authorizing settlement of the lawsuit filed by Peggy Ung against the City and County of San Francisco for \$50,000; the lawsuit was filed on November 8, 2017, in San Francisco Superior Court, Case No. CGC-17-562378; entitled Peggy Ung v. Yong L. Wang, et al.; the lawsuit involves alleged personal injury on a City sidewalk; other material terms of the settlement are that the City, Yong L. Wang, Michelle Wang, and Farmers Insurance Company mutually waive any and all rights they may have against each other for indemnity concerning the lawsuit.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Peggy Ung v. Yong L. Wang, et al.</u>, San Francisco Superior Court, Case No. CGC-17-562378 by the payment of \$50,000 and that the City, Yong L. Wang, Michelle Wang, and Farmers Insurance Company mutually waive any and all rights they may have against each other for indemnity concerning the lawsuit. The lawsuit involves alleged personal injury on a City sidewalk.

Section 2. The above-named action was filed in San Francisco Superior Court on November 8, 2017, and the following parties were named in the lawsuit: Plaintiff Peggy Ung; Defendants Yong L. Wang, Michelle Wang, and City and County of San Francisco.
