The lawsuit involves a claim for attorney's fees and costs following Petitioner's challenge to Ordinance No. 38-17 on the grounds, in part, that San Francisco's approval of Ordinance No. 38-17 violated CEQA and that Ordinance No. 38-17 violated petitioners' constitutional rights.
