Resolution urging the San Francisco Municipal Transportation Agency to implement California Assembly Bill 144 to curb abuse of disabled placards.

WHEREAS, Abusers of disabled placards cause hardship for disabled persons with valid placards by preventing them from finding accessible parking, and

WHEREAS, Abusers of disabled placards undermine the legitimate needs of people truly in need of disabled placards, and

WHEREAS, placard abusers prevent law-abiding drivers from parking legally by using the placard to park for free without time restrictions, and

WHEREAS, There are 23 million registered drivers in the State of California and over 2.3 million of them have disabled placards; between 1997 and 2007 there was a 131% increase in the number of disabled placards issued in California and a 121% increase in the number of disabled placards issued and registered in San Francisco with only a 17% increase in the number of cars registered in San Francisco, and

WHEREAS, There have been 1,234 improperly used placards confiscated in San Francisco between September 2007 and September 2008, and

WHEREAS, disabled parking placards are issued by the Department of Motor Vehicles (DMV) with no local input or oversight and with broad guidelines for medical practitioners who authorize the issuance of placards, and

WHEREAS, The DMV does not regularly investigate medical practitioners who authorize an unusually high number of placards making enforcement the primary effective mechanism available to San Francisco in the effort to curtail abuse of disabled parking privileges, and

WHEREAS, SFMTA needs more tools to minimize the number of disabled placards in use, and

WHEREAS, Assemblywoman Fiona Ma has introduced Assembly Bill 144 to address the problem of disabled parking placard abuse, and

WHEREAS, AB 144 amends the California Vehicle Code to authorize a penalty of up to \$1,000 for parking in a blue zone without a valid license plate or placard or for the misuse of a special license plate or placard and increases the maximum allowed fine for parking in a blue zone from \$500 to \$1,000, and increases the maximum allowed fine for using an invalid placard, or for misuse of a valid disabled parking license plate or placard from \$100 to \$1,000, and

WHEREAS, AB 144, once in effect on January 1, 2010, will allow San Francisco Parking Enforcement Officers to enforce abuses of disabled parking privileges through the issuance of a non-criminal parking citation to a vehicle and SFMTA will be required to take steps in training and resource allocation to implement AB 144 locally, now, therefore, be it

RESOLVED, that the City and County of San Francisco urges SFMTA to take the appropriate steps to implement AB 144 locally in order to curb the abuse of disabled placards.
