On December 19, 2019, a memo was sent to all Members of the Board of Supervisors, surveying their interest in serving on vacant seats to outside boards and commissions.

Summary:

- Association of Bay Area Government (Executive Board) (ABAG) All Supervisors declined the opportunity to be appointed to Seats 3, 4, and 6.
- Golden Gate Bridge, Highway and Transportation District (GGHTD) Supervisor Stefani expressed interest in Seat 5. Therefore, we will forward the nomination of Supervisor Stefani, to the Rules Committee.
- California State Association of Counties (CSAC) All Supervisors declined the opportunity to be appointed to Seats 1 and 2, therefore, CSAC will not have Board of Supervisors representation.
- Children and Families First Commission All Supervisors declined the opportunity to be appointed to Seat 1, therefore, the Commission will not have Board of Supervisors representation.
- Local Agency Formation Commission (LAFCo) All Supervisors declined the opportunity to be appointed to Seats 1 and 5.
- Urban Counties Caucus All Supervisors declined the opportunity to be appointed to Seat 1, therefore, the caucus will not have Board of Supervisors representation.
- San Francisco Int' l Airport (SFO) Community Roundtable All Supervisors declined the opportunity to be appointed to the alternate Seat 2.

For all the remaining vacancies, we will poll again in the Spring.
