Ordinance authorizing settlement of the lawsuit filed by Scanvinski Jerome Hymes against the City and County of San Francisco for \$35,000; the lawsuit was filed on July 28, 2016, in United States District Court – Northern District of California, Case No. 16-cv-04288 JSC; entitled Scanvinski Jerome Hymes v. Be it ordained by the People of the City and County of San Francisco:

Milton Bliss, et al.</u>, United States District Court – Northern District of California, Case No. 16-cv-04288 JSC by the payment of \$35,000. The lawsuit involves alleged excessive force and personal injuries by Sheriff's deputies.
