[Accept and Expend Grant - Retroactive - United States Department of Health and Human Services National Institutes of Health - Magee-Womens Research Institute and Foundation -Leadership and Operations Center (LOC): Microbicide Trials Network - \$134,610]

Resolution retroactively authorizing the Department of Public Health to accept and expend a grant in the amount of \$134,610 from the United States Department of Health and Human Services National Institutes of Health through the Magee-Womens Research Institute and Foundation for participation in a program, entitled "Leadership and Operations Center (LOC): Microbicide Trials Network," for the period of December 1, 2019, through November 30, 2020.

WHEREAS, The United States Department of Health and Human Services National Institutes of Health, through Magee-Womens Research Institute and Foundation (MWRIF) as a pass-through entity, has agreed to fund the San Francisco Department of Public Health (DPH) in the amount of \$134,610 for participation in a program, entitled "Leadership and Operations Center (LOC): Microbicide Trials Network," for the period of December 1, 2019, through November 30, 2020; and
