[Settlement of Unlitigated Claim - Estate Research Associates - \$82,465.14]

WHEREAS, Estate Research Associates ("ERA") filed a claim on January 26, 2018, against the City and County of San Francisco; and

WHEREAS, The claim involves damages allegedly arising from the City's failure to properly administer two estates; and

WHEREAS, In Resolution No. 389-18, the Board of Supervisors previously authorized the City Attorney to settle the claim by payment up to \$80,000 based on estimated distributions by the Probate Court; and

WHEREAS, Actual distributions by the Probate Court increased the value of the claim to \$82,465.14; and

WHEREAS, As part of the settlement, ERA agrees to provide the City with a 60-day period to resolve future unclaimed estate disputes before Claimant files a Government Code claim; now, therefore, be it

RESOLVED, That pursuant to Administrative Code, Section 10.22, the Board of Supervisors hereby authorizes the City Attorney to settle the claim by payment of \$82,465.14 to ERA.
