Motion amending Motion No. M18-058 to withdraw the request for the Budget and Legislative Analyst to conduct a performance audit in FY2018-2019 of the trends in Muni ridership and revenues, including reasons for declines in ridership and revenues compared to prior fiscal years, and the effectiveness of the Municipal Transportation Agency's policies in managing traffic congestion and the impact of traffic congestion on Muni.

WHEREAS, The Board of Supervisors passed Motion No. M18-058, on file with the Clerk of the Board of Supervisors in File No. 180372, on April 24, 2018, which directed the Budget and Legislative Analyst to conduct a performance audit in FY2018-2019 of the trends in Muni ridership and revenues, including reasons for declines in ridership and revenues compared to prior fiscal years, and the effectiveness of the San Francisco Municipal Transportation Agency's policies in managing traffic congestion and the impact of traffic congestion on Muni; and

WHEREAS, The Mayor, Supervisor Mandelman and Supervisor Peskin later convened a San Francisco Municipal Transportation Agency Muni Reliability Working Group that reviewed Muni transit operations performance and improvement work, identified needs, and recommended priority actions to improve Muni performance for the use of policymakers in a Controller's Report in January 2020; and

WHEREAS, A new Director of the San Francisco Municipal Transportation Agency has been recruited and retained to carry out the Working Group's policy recommendations; and

WHEREAS, The Budget and Legislative Analyst Office has still not completed the performance audit and has a full workload of additional audit requests; now, therefore, be it
