
Dear Ms. Alabanza:



10 WHEREAS, Destination Bars, Inc., is seeking the premise-to-premise transfer of
11 a Type-48 on-sale general public premises liquor license, to do business as The Lark
12 Bar, located at 685 Market Street, Suite A (District 6); and

13 WHEREAS, The Planning Department has verified that the area is properly
14 zoned and recommends approval; and

15 WHEREAS, The Police Department has filed zero protests and 22 letters of
16 support with the Department of Alcoholic Beverage Control under California Business
17 and Professions Code, Section 24013, and recommends that the Department of
18 Alcoholic Beverage Control issue the liquor license with conditions; and

19 WHEREAS, The conditions recommended by the Police Department are the
20 following: 1) Petitioner(s) shall actively monitor the area under their control in an effort
21 to prevent the loitering of persons on any property adjacent to the licensed premise as
22 depicted on ABC-253; and 2) No noise shall be audible at any nearby residences; now,
23 therefore, be it

24 RESOLVED, That in accordance with California Business and Professions Code,
25 Section 23958.4, the Board of Supervisors of the City and County of San Francisco

1 hereby determines that the premise-to-premise transfer of a Type-48 on-sale general
2 public premises liquor license to Destination Bars, Inc., doing business as the Lark Bar,
3 located at 685 Market Street, Suite A, will serve the public convenience or necessity of
4 the City and County of San Francisco; and, be it




