3 **Motion appointing Devin Jones (residency requirement waived), Darcy Brown and**
4 **Daniel Kling, terms ending April 10, 2021, to the Graffiti Advisory Board.**

6 MOVED, That the Board of Supervisors of the City and County of San Francisco does
7 hereby appoint the hereinafter designated person to serve as a member of the Graffiti
8 Advisory Board, pursuant to the provisions of Administrative Code, Section 5.170 et seq., for
9 the term specified:

10 Devin Jones (residency requirement waived), Seat 12, succeeding John Austin,
11 resigned, must represent youth groups that provides services for juveniles involved in
12 alternative programs for graffiti diversion, for the unexpired portion of a two-year term ending
13 April 10, 2021;

14 Darcy Brown, Seat 13, succeeding themselves, term expired, must be an employee,
15 officer or member of a nonprofit organization that provides services related to the City's
16 beautification and neighborhood cleanup programs, for the unexpired portion of a two-year
17 term ending April 10, 2021;

18 Daniel Kling, Seat 15, succeeding themselves, term expired, must represent a business
19 that operates in San Francisco, and either seat 14 or 15 must own the property where his or
20 her business operates, for the unexpired portion of a two-year term ending April 10, 2021;
21 and, be it

22 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 23 1. The membership of the Graffiti Advisory Board has a goal to be representative of
24 the diversity of the City and County of San Francisco.

- 1 2. Applicant Devin Jones, who is not a resident of San Francisco, is a person with
- 2 experience that uniquely qualifies her to serve on the Graffiti Advisory Board.
- 3 3. The Graffiti Advisory Board has attempted to fill the position, for which Devin Jones
- 4 was nominated, with an individual who is City resident and who have the specific
- 5 experience, skills, and qualifications, but has been unable to do so at this time. The
- 6 Rules Committee has certified that Devin Jones is qualified to serve on the Graffiti
- 7 Advisory Board.
- 8 4. After exercising due diligence, the Board of Supervisors concludes that there are no
- 9 other possible representative, who is a resident of San Francisco, and who has the
- 10 specific experience, skills, or qualifications possessed by this applicant, and who is
- 11 willing to serve on the Graffiti Advisory Board at this time; and, be it

12 FURTHER MOVED, That the Board of Supervisors waives the residency requirement
13 for Devin Jones, as allowed in cases where no qualified City resident, willing to serve, can be
14 found, pursuant to Charter, Section 4.101(a)(2), that requires person(s) appointed to boards,
15 commissions, and advisory bodies established by legislative act of the Board of Supervisors
16 to be resident(s) of the City and County of San Francisco.


