## ORDINANCE NO.

[Settlement of Lawsuit - Virginia Ernster - \$70,000]

Ordinance authorizing settlement of the lawsuit filed by Virginia Ernster against the City and County of San Francisco for \$70,000; the lawsuit was filed on May 21, 2019, in San Francisco Superior Court, Case No. CGC-19-576126; entitled <u>Virginia Ernster and</u> <u>Martin Ernster v. City and County of San Francisco, Cristina Couch</u>; the lawsuit involves an alleged personal injury from a vehicle collision.

Be it ordained by the People of the City and County of San Francisco:

Section 1.
