Resolution retroactively authorizing the Police Department to accept and expend a grant in the amount of \$298,414 from the Department of Homeland Security Federal Emergency Management Agency to purchase an underwater remote operated vehicle, for the period of September 1, 2019, through August 31, 2022, and waiving indirect costs.

This equipment will give us the ability to search for and mitigate underwater threats; conduct security sweeps of the piers, sea wall system, and moored vessels; recover evidence safely and quickly without having to deploy human divers; and provide post incident underwater surveillance of infrastructure. This maritime security increases the economic vitality of the port, and the stability and resiliency of the port facilities, which are all part of the Port of San Francisco's 2016-2021 Strategic Plan.

There are currently no other similarly capable ROVs in the San Francisco Regional Bay Area. There are three (3) other smaller ROV systems in the region, none of which can operate in the swift bay currents due to their thruster size and lack of navigation systems. The ability to deploy a more powerful ROV is critical to San Francisco, and provides critical coverage as a regional asset that can easily be transported to any waters of our partners agencies.
