[Settlement of Lawsuit - Jennie Feldman - \$150,000]

Ordinance authorizing settlement of the lawsuit filed by Jennie Feldman against the City and County of San Francisco for \$150,000; the lawsuit was filed on July 3, 2019, in San Francisco Superior Court, Case No. CGC-19-577368; entitled <u>Jennie Feldman v.</u> <u>City and County of San Francisco, et al.</u>; the lawsuit involves alleged personal injury from a falling tree branch.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Jennie Feldman v. City and County of San Francisco, et al.</u>, San Francisco Superior Court, Case No. CGC-19-577368 by the payment of \$150,000. The lawsuit involves alleged personal injury from a falling tree branch.
