[Settlement of Lawsuit - Garry Peace - \$43,500]

Ordinance authorizing settlement of the lawsuit filed by Garry Peace against the City and County of San Francisco for \$43,500; the lawsuit was filed on November 8, 2017, in San Francisco Superior Court, Case No. CGC-17-562373; entitled Garry Peace v. City and County of San Francisco; the lawsuit involves an alleged personal injury while walking on a City sidewalk.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Garry Peace v. City and County of San Francisco, San Francisco Superior Court, Case No. CGC-17-562373 by the payment of \$43,500. The lawsuit involves an alleged personal injury while walking on a City sidewalk.

Section 2. The above-named action was filed in San Francisco Superior Court on November 8, 2017, and the following parties were named in the lawsuit: Garry Peace, Plaintiff, and City and County of San Francisco, Defendant.


