[Accept and Expend Grant - Retroactive - County Victim Services Program - California Governor's Office of Emergency Services - \$451,544]

Resolution retroactively authorizing the Office of the District Attorney to accept and expend a grant in the amount of \$451,544 from the California Governor's Office of Emergency Services for the County Victim Services Program, for the grant period of January 1, 2020, through December 31, 2020.

WHEREAS, California Governor's Office of Emergency Services (Cal OES) awarded \$451,544 to the Office of the District Attorney for the County Victim Services (XC) Program; and

  - It represents that (1) it has determined that no other entity that the Subrecipient's application proposes may or will receive award funds (whether through a subaward, procurement contract, or subcontract under a procurement contract) either requires or has required internal confidentiality agreements or statements from employees or contractors that currently prohibit or otherwise currently restrict (or purport to prohibit or restrict) employees or contractors from reporting waste, fraud, or abuse as described above; and (2) it has made appropriate inquiry, or otherwise has an adequate factual basis, to support this representation; and
  - It certifies that, if it learns or is notified that any Subrecipient, contractor, or subcontractor entity that receives funds under this award is or has been requiring its employees or contractors to execute agreements or statements that prohibit or otherwise restrict (or purport to prohibit or restrict), reporting of waste, fraud, or abuse as described above, it will immediately stop any further obligations of award funds to or by that

entity, will provide prompt written notification to the federal agency making this award, and will resume (or permit resumption of) such obligations only if expressly authorized to do so by that agency.

#### 10. Encouragement of Policies to Ban Text Messaging while Driving

The Subrecipient authorizes the Office for Victims of Crime (OVC) and/or the Office of the Chief Financial Officer (OCFO), and its representatives, access to and the right to examine all records, books, paper or documents related to the VOCA grant.

All appropriate documentation must be maintained on file by the project and available for Cal OES or public scrutiny upon request. Failure to comply with these requirements may result in suspension of payments under the grant or termination of the grant or both and the Subrecipient may be ineligible for subaward of any future grants if the Cal OES determines that any of the following has occurred: (1) the Subrecipient has made false certification, or (2) violates the certification by failing to carry out the requirements as noted above.

#### Α. **PERSONAL SERVICES**

#### \$447,716

There are five individuals assigned full-time or part-time to the XC Grant for a project total of 3.75 FTE and \$305,427. Personnel assigned to the XC program include:

2 Victim/Witness Investigators 1 – Advocate (8129)

- 1 Victim/Witness Investigator 1 Advocate (8131)
- 1 Public Service Aide Associate Advocate (9914)
- 1 Assistant Chief Victim/Witness Investigator (8135)

8129 Victim Witness Investigator 1 - Advocate. Victim Advocates from the 8129 job class are responsible for direct client services, developing and managing partnerships with other government and community based services. They will work with charged and uncharged criminal cases, participate on the Mass Casualty Crimes Team, and will conduct community outreach events.

9914 Public Service Aide - An Associate Advocate will work with the homicide, mass casualty crimes team, and community team. This position is a trainee position. This position will be supervised by the Assistant Chief Victim/Witness

Investigator. They will work with uncharged criminal cases, participate on the Mass Casualty Crimes Team, and will conduct community outreach events.

8135 Assistant Chief Victim/Witness Investigator – The Assistant Chief of Victim/Witness Investigator manages the mass casualty crimes team, the homicide team, and the community team. This position requires a minimum of 4 years of training, education, and/or experience in social welfare, behavioral science, criminology, psychology or closely related field and responsible social service, criminal justice or advocacy experience. This position is responsible for the grant deliverables, reporting and statistics.

8131 Victim/Witness Investigator II – The Victim/Witness Investigator II supervises and performs a wide variety of investigative and legal support duties; interviews victims and witnesses; prepares reports on investigations of average difficulty or complexity; collects, compiles and assists in preparation of data in the area of criminal justice services; evaluates and prepares criminal cases; implements crime victims criminal justice policy; maintains informational sources; participates in meetings, presentations, and workshops; supervises and trains investigators, technicians, interns and volunteers engaged in routine work.

Standard fringe benefits are allocated to the grant and include social security, Medicare, retirement, state unemployment compensation insurance, long-term

#### Victim Emergency Fund

a. Victim Services Division Emergency Fund : In the event of an emergency, victims of crime may require immediate financial assistance to ensure their safety and basic needs. The application

process for state victim compensation funds does not provide immediate relief to victims of crime. Additionally, not all resources needed by victims after emergencies are allowable under the guidelines of the state victim compensation program. This fund will provide resources to meet victims' basic needs such as temporary emergency shelter, food, transportation, clothing and medical care, including prescription medicine, eyeglasses, or dentures.

b. Emergency Gift Cards: Gift cards are provided to victims to allow for purchase of emergency needs like food, clothing, toiletries and medication. The Advocate working with the client can request the cards for their victims when an immediate and specific need is determined. Gift cards are logged, dated and inventoried to ensure they are used only for current clients and that approval has been secured for distribution. Benefit is also noted in case file.

The fund will include \$11,280 in petty cash and \$2,700 in gift cards for a total of \$13,980.

- 1. The Petty Cash Victim Fund and regular grant allocation funds must be kept separate, each with its own account within the general ledger.
- 2. The authority to disburse funds to victims from the Petty Cash Victim Fund rests with the Project Director, Financial Officer, and/or those identified on the Signature Authorization Form (Cal OES 2-103).
- 3. The name and signature of the victim and the employee disbursing the funds must be maintained, as well as the date, amount, and reason for the request.
- 4. Direct cash disbursements will be limited to no more than <u>\$200</u> per individual. Victims are not eligible to draw on the Petty Cash Victim Fund for more than \$200 per year.

#### Project Narrative

#### 1. Problem Statement

#### Demographics

The City and County of San Francisco is the financial and cultural core of a metropolitan area composed of nine Bay Area counties with a combined population that exceeds 7 million people. The City and County of San Francisco, the only city-county dual jurisdiction government in California, covers approximately 46 square miles and is home to an estimated 852,469 people (U.S. Census Bureau Quickfacts).

San Francisco is the center of international tourism and a major commuter destination; its daytime population exceeds 1.5 million. San Francisco is extremely dense and ethnically, linguistically and socio-economically diverse. A disproportionately large number of Limited English Proficient (LEP) families and communities come to the City and County of San Francisco in search of community-based services and government systems that are more culturally and linguistically competent to meet their basic needs than those in other areas of the state. The primary social factors that influence life in San Francisco are the cultural, ethnic, and linguistic diversity of residents and the density of the population with approximately 18,500 residents per square mile, 44% of which are family households. San Francisco's ethnic diversity includes approximately 54% White, 34% Asian/Pacific Islander, 15% Hispanic/Latino, and 6% African American residents. Amongst this ethnic diversity the low-income African Project Narrative – Cal OES 2-108 (Revised 3/2019)

Americans and Latinos disproportionately live in neighborhoods which are most impacted by violent crime. In addition to the permanent residents of San Francisco, the City is home to 25 colleges and universities, with thousands of students from all over the world.

#### Crime types

The Victim Services Division served more than 8,600 victims and survivors of all crimes in 2018; providing crisis intervention, restraining order assistance, information about the criminal justice system, victims of crime compensation assistance, advising on case status, court escort and waiting, assistance with writing victim impact statements, relocation assistance, funeral arrangements, and restitution. Crime types of victims served included domestic violence, 24%; assault, 23%; robbery 17%, survivors of homicide and domestic violence of a child, both 4%, child sex assault and elder abuse and threats, each 3%; sex assault, child physical abuse, hit and run all 2% and 13% were crime that fell outside of these categories. Analysis of new victims served show ethnic identification of victims as 14% Asian (21% African American,)25%. White, 34% Latino and 6% other ethnicities.

## Gaps/Needs

San Francisco's risk of natural disasters like earthquakes, tsunamis and severe storms is well documented and planned for, but more uncommon emergencies like terrorism or mass casualty events that involve victims of crime are

unfortunately a growing concern for the city. Events like those in Boston, Paris, Brusselsn San Bernardino and throuht the country are a reminder of both the need to plan and prepare and impact these terrible incidents can have on our communities. San Francisco is at greater risk of terrorist incidents than other small urban areas due to its high profile, national image and the large number of tourists who visit the city each day (SFDEM.org).

Over the past five years, the San Francisco District Attorney's Office Victim Services Division has been identifying, assessing and responding to gaps and needs in services. Many of those issues have been addressed, but one glaring challenge that has the potential to impact large numbers of victims, witnesses and the entire community is mass casualty crime victim events. Terrorism, active shooters, and other mass casualty crime events (defined by USC Title 18 as 3 or more victims in a single incident). Our office has identified and prioritized the goal to collaborate, plan and practice for responding to mass casualty crime victim events. Our objectives are to 1) develop a plan for multiple scenarios of mass crime victim incidents, 2) determine effective responses and the resources needed to assist crime victims, 3) practice and prepare for the responses with other first responders and 4) build capacity and resiliency in the community by serving victims of community and mass casualty crime.

#### Impact of Addressing Gaps/Needs

In 2016, we took the first step of planning for responding to a mass casualty crime event by convening the Victim Services Steering Committee (VSSC). The committee has worked diligently the past two years on evaluating and holding stakeholder meetings with the goal of producing and implementing a multiagency plan for responding to victims of mass casualty crime incidents that could affect hundreds, or even thousands of residents in the event of a crisis. The committee has researched existing plans, consulted with experts in the field, and has drafted a proposed plan. The draft plan is currently in the editing and review process.

The proposal is to continue the work that has been started by coordinating ongoing planning, training and practice for critical events involving victims of mass crime, which will help minimize loss of life, organize and facilitate timely effective responses, plan for maximizing supports and resources for victims, witnesses, families and the community members affected by crime events. In addition, this implementation process will help us build resiliency in the San Francisco community by strengthening partnerships with disaster response stakeholders so in the event we have to respond to a mass crime casualty incident our response will be coordinated, organized, and effectively meet the needs of victims, witnesses, and community members impacted by the mass crime incident.

This process will also allow us to address the complex issues of 'at risk', vulnerable and special need victim populations in the city of San Francisco. During the first two years of this process we worked closely with domestic violence and sexual assault providers to address gaps in disaster planning for these vulnerable populations. This process will allow us to continue to examine how disaster response policies and protocols disproportionally impact people who due to age; physical, mental, or cognitive challenges; culture, religion, language or citizenship; or socioeconomic status may have unique barriers or challenges in, the event of a mass crime victim event. When we are better able to anticipate and plan for needs, we can better serve victims in the time of a crisis event.

Finally, this proposal will allow us to serve victims of community and mass casualty crime in San Francisco and the surrounding Bay Area. While mass violence incidents are infrequent, acts of public violence that impact neighborhoods and communities in San Francisco happen more frequently. These acts of public violence we refer to as community violence since they not only impact those directly involved but have a broader impact on the neighborhood at-large. In San Francisco, the agencies that plan to respond to incidents of mass casualty crime are the same agencies that respond to incidences of community violence. By responding to victims of community violence incidents, we will be better prepared to scale up the response with the same partner agencies in the event of a mass casualty crime.

2. Plan

Our steering committee members have identified continued mass crime victim casualty planning, training and preparedness as the greatest need in the City and County of San Francisco. Army, the Red Cross, San Francisco Fire Department (including the Neighborhood Response Team), the San Francisco International Airport, and other community-based organizations. We will continue to work closely with these stakeholders and invite them to participate in the SFVSSC.

Our proposal is to manage a Victim Services Steering Committee including the following objectives and activities.

**Objective 1:** Review existing department and agency plans regarding mass crime victim events and develop new plans, protocols or policies as needed or identified.

Activities:

- a. Review current city and county department plans and draft mass casualty crime event plans
- b. Document Victim Services Division's roles, responsibilities and deployment guidelines in these plans.
- c. Integrate into systems and/or develop new plan(s) as needed
- d. Obtain final sign-off of report by end grant term
- e. Publish report (hard and electronic copies) and distribute to all partners serving victims of crime
- f. Meet as a steering committee on a quarterly basis

**Objective 2:** Train with multiagency teams to respond to mass casualty crime victim incidents.

Activities:

#### 3. Capabilities

The purpose of this section is to further outline the capacity and commitment of the San Francisco District Attorney's Office to implement and manage the

proposed grant program. The enclosed organizational chart presents a graphic depiction of the management hierarchy and service delivery plan.

**Capacity to Implement Plan:** The Chief of Victim Services and Parallel Justice Programs, Gena Castro Rodriguez, will bear primary responsibility for the oversight of the grant, including management of programmatic and fiscal requirements. She will be responsible for ensuring the outcomes and objectives of the grant are met during the term of the grant, that all reporting is submitted in timely manner, and supervise the staff and volunteers managing the objectives of the contract. The proposed full time program specialist (Victim Witness Investigator 8133) for the position will be responsible convening and managing the steering committee, coordinating and staffing workgroups, reviewing existing plan and developing new plans and documents, coordinating all trainings, managing practice drills, contributing to reporting and evaluation process, managing all documents, and work products as result of the grant and steering committee work.


**Capacity to Manage Grant Programs:** The Chief of Victim Services and Parallel Justice Programs, Gena Castro Rodriguez is lead representative for the office on programmatic grant responsibilities for the Victim Services Division. Her position oversees pre- and post-award grant administration and ensures regulatory compliance and may manage grant-funded programs. In addition to grant

administration, the Chief of Victim Services and Parallel Justice Programs may serve as the liaison with the funding agency and submit reports and modifications to the funding agency. Gena Castro Rodriguez, Chief of Victim Services and Parallel Justice Programs, has more than 20 years of grant administration experience.


The SFDA Assistant Chief of Finance and Administration and the Fiscal Analyst serve as lead for grant related budgetary responsibilities. This team works together on multiple grants in our department and is in complete compliance with all requirements for city, state, and federal grants.



8129 Victim Witness Investigator 1 - Advocate. Victim Advocates from the 8129 job class are responsible for direct client services, developing and managing partnerships with other government and community based services. They will work with charged and uncharged criminal cases, participate on the Mass Casualty Crimes Team, and will conduct community outreach events.

9914 Public Service Aide – An Associate Advocate will work with the homicide, mass casualty crimes team, and community team. This position is a trainee position. This position will be supervised by the Assistant Chief Victim/Witness

Investigator. They will work with uncharged criminal cases, participate on the Mass Casualty Crimes Team, and will conduct community outreach events.

8135 Assistant Chief Victim/Witness Investigator – The Assistant Chief of Victim/Witness Investigator manages the mass casualty crimes team, the homicide team, and the community team. This position requires a minimum of 4 years of training, education, and/or experience in social welfare, behavioral science, criminology, psychology or closely related field and responsible social service, criminal justice or advocacy experience. This position is responsible for the grant deliverables, reporting and statistics.

8131 Victim/Witness Investigator II – The Victim/Witness Investigator II supervises and performs a wide variety of investigative and legal support duties; interviews victims and witnesses; prepares reports on investigations of average difficulty or complexity; collects, compiles and assists in preparation of data in the area of criminal justice services; evaluates and prepares criminal cases; implements crime victims criminal justice policy; maintains informational sources; participates in meetings, presentations, and workshops; supervises and trains investigators, technicians, interns and volunteers engaged in routine work.

Standard fringe benefits are allocated to the grant and include social security, Medicare, retirement, state unemployment compensation insurance, long-term

The result of the exercise is an action plan for continued improvement of the emergency planning. #### **Project Narrative**

#### 1. Problem Statement

#### **Demographics**

The City and County of San Francisco is the financial and cultural core of a metropolitan area composed of nine Bay Area counties with a combined population that exceeds 7 million people. The City and County of San Francisco, the only city-county dual jurisdiction government in California, covers approximately 46 square miles and is home to an estimated 852,469 people (U.S. Census Bureau Quickfacts).

San Francisco is the center of international tourism and a major commuter destination; its daytime population exceeds 1.5 million. San Francisco is extremely dense and ethnically, linguistically and socio-economically diverse. A disproportionately large number of Limited English Proficient (LEP) families and communities come to the City and County of San Francisco in search of community-based services and government systems that are more culturally and linguistically competent to meet their basic needs than those in other areas of the state. The primary social factors that influence life in San Francisco are the cultural, ethnic, and linguistic diversity of residents and the density of the population with approximately 18,500 residents per square mile, 44% of which are family households. San Francisco's ethnic diversity includes approximately 54% White, 34% Asian/Pacific Islander, 15% Hispanic/Latino, and 6% African American residents. Amongst this ethnic diversity the low-income African

Americans and Latinos disproportionately live in neighborhoods which are most impacted by violent crime. In addition to the permanent residents of San Francisco, the City is home to 25 colleges and universities, with thousands of students from all over the world.

#### Crime types

The Victim Services Division served more than 8,600 victims and survivors of all crimes in 2018; providing crisis intervention, restraining order assistance, information about the criminal justice system, victims of crime compensation assistance, advising on case status, court escort and waiting, assistance with writing victim impact statements, relocation assistance, funeral arrangements, and restitution. Crime types of victims served included domestic violence, 24%; assault, 23%; robbery, 17%, survivors of homicide and domestic violence of a child, both 4%; child sex assault and elder abuse and threats, each 3%; sex assault, child physical abuse, hit and run all 2% and 13% were crime that fell outside of these categories. Analysis of new victims served show ethnic identification of victims as 14% Asian, 21% African American, 25% White, 34% Latino and 6% other ethnicities.

#### Gaps/Needs

San Francisco's risk of natural disasters like earthquakes, tsunamis and severe storms is well documented and planned for, but more uncommon emergencies like terrorism or mass casualty events that involve victims of crime are

unfortunately a growing concern for the city. Events like those in Boston, Paris, Brussels, San Bernardino and throughout the country are a reminder of both the need to plan and prepare and impact these terrible incidents can have on our communities. San Francisco is at greater risk of terrorist incidents than other small urban areas due to its high profile, national image and the large number of tourists who visit the city each day (SFDEM.org).

Over the past five years, the San Francisco District Attorney's Office Victim Services Division has been identifying, assessing and responding to gaps and needs in services. Many of those issues have been addressed, but one glaring challenge that has the potential to impact large numbers of victims, witnesses and the entire community is mass casualty crime victim events. Terrorism, active shooters, and other mass casualty crime events (defined by USC Title 18 as 3 or more victims in a single incident). Our office has identified and prioritized the goal to collaborate, plan and practice for responding to mass casualty crime victim events. Our objectives are to 1) develop a plan for multiple scenarios of mass crime victim incidents, 2) determine effective responses and the resources needed to assist crime victims, 3) practice and prepare for the responses with other first responders and 4) build capacity and resiliency in the community by serving victims of community and mass casualty crime.

### Impact of Addressing Gaps/Needs

In 2016, we took the first step of planning for responding to a mass casualty crime event by convening the Victim Services Steering Committee (VSSC). The committee has worked diligently the past two years on evaluating and holding stakeholder meetings with the goal of producing and implementing a multiagency plan for responding to victims of mass casualty crime incidents that could affect hundreds, or even thousands of residents in the event of a crisis. The committee has researched existing plans, consulted with experts in the field, and has drafted a proposed plan. The draft plan is currently in the editing and review process.

The proposal is to continue the work that has been started by coordinating ongoing planning, training and practice for critical events involving victims of mass crime, which will help minimize loss of life, organize and facilitate timely effective responses, plan for maximizing supports and resources for victims, witnesses, families and the community members affected by crime events. In addition, this implementation process will help us build resiliency in the San Francisco community by strengthening partnerships with disaster response stakeholders so in the event we have to respond to a mass crime casualty incident our response will be coordinated, organized, and effectively meet the needs of victims, witnesses, and community members impacted by the mass crime incident.

This process will also allow us to address the complex issues of 'at risk', vulnerable and special need victim populations in the city of San Francisco. During the first two years of this process we worked closely with domestic violence and sexual assault providers to address gaps in disaster planning for these vulnerable populations. This process will allow us to continue to examine how disaster response policies and protocols disproportionally impact people who due to age; physical, mental, or cognitive challenges; culture, religion, language or citizenship; or socioeconomic status may have unique barriers or challenges in the event of a mass crime victim event. When we are better able to anticipate and plan for needs, we can better serve victims in the time of a crisis event.

Finally, this proposal will allow us to serve 500 victims of crime in San Francisco. Recently, our office location moved. We now have offices in two locations where our staff will meet with clients: The Hall of Justice (850 Bryant Street) where victims will come to check in and get a briefing from their advocate before their court hearings and our main Victim Services Office (350 Rhode Island Street) where victims will come to have meetings with their advocate or walk in for appointments or services. This proposal will allow us to hire another Victim Advocate (8129) to serve as the first point of contact when victims come to our offices. This Advocate will provide immediate crisis services, connection to their specialized advocate, assistance with victims' compensation, and referrals to resource and services for victims. This proposal will also allow us to serve victims of domestic violence and elder abuse.

While mass violence incidents are infrequent, acts of public violence that impact neighborhoods and communities in San Francisco happen more frequently. These acts of public violence we refer to as community violence since they not only impact those directly involved but have a broader impact on the neighborhood at-large. In San Francisco, the agencies that plan to respond to incidents of mass casualty crime are the same agencies that respond to incidences of community violence. By responding to victims of community violence incidents, we will be better prepared to scale up the response with the same partner agencies in the event of a mass casualty crime.

In addition to the work being done by our advocates, this proposal will allow us to partner and expand our reach and leverage general fund dollars to support a local community-based agency that serves victims of crime that are hesitant to engage with law enforcement services directly. The 3<sup>rd</sup> Street Youth Center & Clinic/Larkin Street Youth Services serves youth (ages 12-24) from Bayview Hunters Point (BVHP) through a full-service behavioral health clinic that provide individual and group therapy and clinical case management to youth and their families. They also provide low-barrier, flexible rapid re-housing and case management to homeless young people that are experiencing violence on the streets. This partnership will allow this agency to screen and provide appropriate services and referrals to 100 Bay View Hunters Point residents for their mental

health needs as a result of experiencing or witnessing a crime or violence. Finally, additional staff members on this grant as direct personnel and in-kind match will provide direct victim advocacy services of crisis intervention, juvenile justice system information, referral to resources and services, safety planning and victim of crime compensation for victims of domestic violence, elder abuse and sexual assault.

#### 2. Plan

Our steering committee members have identified continued mass crime victim casualty planning, training and preparedness as the greatest need in the City and County of San Francisco. The committee has committed to participating in meeting the outcomes outlined in this proposal). Members of the current San Francisco Victim Services Steering Committee (SFVSSC) include:

Human Services Agency of San Francisco, which includes

- Adult Protective Services
- o Child Protective Services
- San Francisco Superior Courts
- San Francisco Department of Public Health, which includes
  - o Trauma Recovery Center
- San Francisco Police Department
- San Francisco Adult Probation Department
- San Francisco Sheriff's Department

- San Francisco Medical Examiner
- San Francisco Department of Emergency Management
- La Casa De Las Madres- Domestic Violence and Sexual Assault Services

During the planning process over the past two years, we worked closely with additional stakeholders from our Level One Trauma Treatment Center-San Francisco General Hospital (also under the Dept. of Public Health), the Salvation Army, the Red Cross, San Francisco Fire Department (including the Neighborhood Response Team), the San Francisco International Airport, and other community-based organizations. We will continue to work closely with these stakeholders and invite them to participate in the SFVSSC.

Our proposal is to manage a Victim Services Steering Committee including the following objectives and activities.

Objective 1: Serve 500 victims of violence, including victims of mass and community violence, domestic and elder abuse during the year. Activities:

- a. Develop strong referral relationships with partner agencies that work with victims of community and mass violence.
- b. Provide crisis intervention counseling, referral to services and resources, restraining order assistance, information about the criminal justice system,

victims of crime compensation assistance, advising on case status, court escort and waiting, assistance with writing victim impact statements, relocation assistance, funeral arrangements, and restitution information to victims of community and mass violence for 500 victims.

- c. Expand our reach to victims of crime by providing general fund resources to 3rd Street Youth Center & Clinic/Larkin Street Youth Services to provide services to 100 Bay View Hunters Point youth, including screening for needs, referrals, mental health services, and wrap-around support services.
- d. Provide direct advocacy services for victims of domestic violence, sexual assault and elder abuse including advocacy services of crisis intervention, juvenile justice system information, referral to resources and services, safety planning and victim of crime compensation for 100 victims.

**Objective 2:** Review existing department and agency plans regarding mass crime victim events and develop new plans, protocols or policies as needed or identified.

Activities:

- a. Review current city and county department plans and draft mass casually crime event plans
- b. Document Victim Services Division's roles, responsibilities and deployment guidelines in these plans.

- c. Integrate into systems and/or develop new plan(s) as needed
- d. Obtain final sign-off of report by end grant term
- e. Publish report (hard and electronic copies) and distribute to all partners serving victims of crime

**Objective 3:** Train with multiagency teams to respond to mass casualty crime victim incidents.

Activities:

- a. Continue to recruit and train San Francisco Victim Services Division staff
   members that will be part of the response team from multiple agencies.
   We currently have 23 trained volunteer team members.
- b. Collaborate with Bay Area Mass Casualty Crime Planning Committee (BAMCPC) to practice mutual aid response for mass casualty crime. We currently have formal MOUs with 7 Bay Area counties and plan to add 2 more.
- c. Potential trainings include, but not limited to:
  - Staff Preparedness
  - Family Resource Centers
  - Family Assistance Centers
  - Communication and Command Centers
  - Ongoing Training for Crime Victims

**Objective 4:** Lead and participate in practice drills to test, evaluate and refine performance.

Activities

a. Discussion Based/Tabletop Practice

All SF VSSC members will participate in a daylong crisis preparation exercise with Victims Services Division staff members consisting on a mass crime casualty event scenario. The goals of the exercise include:

- Providing an opportunity to evaluate plans and operations
- Reinforce team work and relationship building
- Identify gaps and problems

b. Operations Based Exercise

All SF VSSC members and Victim Services Division staff will participate in a daylong large-scale crisis response drill consisting on a mass crime casualty event scenario and the establishment of a Family Assistance Center. Volunteers will be used as actors to role play as victims, friends, and family members impacted by a mass casualty crime. The goals of the exercise include:

- Practice deployment, multiagency coordination and logistics
- Test performance of people, equipment and resources
- Identify gaps in resources
- Clarify roles and responsibilities
- Improve individual and team performance

- Evaluate- observe and collect data, analyze data, determine if goals or objectives were met
- Feedback After Action Report
- Refine Plan- After Action Improvement Plan

**Objective 5:** Develop a protocol for accessing, updating and implementing plan on an annual basis.

#### 3. Capabilities

The purpose of this section is to further outline the capacity and commitment of the San Francisco District Attorney's Office to implement and manage the proposed grant program. The enclosed organizational chart presents a graphic depiction of the management hierarchy and service delivery plan.

Project Narrative - Cal OES 2-108 (Revised 3/2019)

**Capacity to Implement Plan:** The Chief of Victim Services and Parallel Justice Programs, Gena Castro Rodriguez, will bear primary responsibility for the oversight of the grant, including management of programmatic and fiscal requirements. She will be responsible for ensuring the outcomes and objectives of the grant are met during the term of the grant, that all reporting is submitted in timely manner, and supervise the staff and volunteers managing the objectives of the contract. The proposed full time program specialist (Victim Witness Investigator 8133) for the position will be responsible convening and managing the steering committee, coordinating and staffing workgroups, reviewing existing plan and developing new plans and documents, coordinating all trainings, managing practice drills, contributing to reporting and evaluation process, managing all documents, and work products as result of the grant and steering committee work.

**Capacity to Manage Grant Programs:** The Chief of Victim Services and Parallel Justice Programs, Gena Castro Rodriguez is lead representative for the office on programmatic grant responsibilities for the Victim Services Division. Her position oversees pre- and post-award grant administration and ensures regulatory compliance and may manage grant-funded programs. In addition to grant administration, the Chief of Victim Services and Parallel Justice Programs may serve as the liaison with the funding agency and submit reports and

modifications to the funding agency. Gena Castro Rodriguez, Chief of Victim Services and Parallel Justice Programs, has more than 20 years of grant administration experience.

The SFDA Assistant Chief of Finance and Administration and the Fiscal Analyst serve as lead for grant related budgetary responsibilities. The finance team is involved in pre-award budget development and the day-to-day fiscal management of the grant, including approval from the Board of Supervisors, tracking expenditures, invoicing, charging personnel time, and cost reimbursement. Only fiscal management staff can draw down federal funds, and coordinate and respond to audits with input from staff with programmatic responsibilities. The finance team under the leadership of Assistant Chief Sheila Arcelona has over 25 years of experience with fiscal administration of grants.

This team works together on multiple grants in our department and is in complete compliance with all requirements for city, state, and federal grants.



# San Francisco District Attorney Justice Innovations and Policy Department Organizational Structure




# San Francisco District Attorney Operations Department Organizational Structur




