6 **entitled Erlinda Barahona, et al. v. City and County of San Francisco, et al.; the lawsuit**
7 **involves alleged personal injury from collision with City vehicle.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Erlinda Barahona, et al. v. City and
12 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-18-572183 by
13 the payment of \$615,000. The lawsuit involves alleged personal injury from collision with City
14 vehicle.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 December 18, 2018, and the following parties were named in the lawsuit: Plaintiffs Erlinda
17 Barahona and Saul Barahona; Defendants City and County of San Francisco and Erik Maher.
