1	[Urging the President of the United States to Exercise the Full Powers of the Defense Production Act During the COVID-19 Emergency]
3	Resolution urging the President of the United States to exercise his powers under the
4	Defense Production Act to compel private manufacturers, insurance providers, and
5	healthcare providers to produce personal protective equipment and provide free
6	testing and other critical healthcare needs during the COVID-19 State of Emergency.
7	
8	WHEREAS, On March 11, 2020, the World Health Organization declared the novel
9	Coronavirus, COVID-19, a pandemic and urged countries to take urgent action to stop the
10	virus; and
11	WHEREAS, The World Health Organization and United States intelligence agencies
12	repeatedly briefed the President of the United States (President) on the emergence of
13	COVID-19 and the threat it posed to Americans throughout January and February 2020; and
14	WHEREAS, The President's decision not to utilize COVID-19 tests offered by the
15	World Health Organization in February 2020 severely inhibited our nation's capacity to
16	monitor and control the spread of COVID-19; and
17	WHEREAS, The Defense Production Act of 1950 authorizes the President to require
18	private companies to sign contracts, fulfill orders, and allocate materials, services, and
19	facilities deemed necessary for national defense; and
20	WHEREAS, The Act also authorizes the President to requisition property, force
21	industry to expand production and the supply of basic resources, impose wage and price
22	controls, and allocate raw materials towards national defense; and
23	WHEREAS, The Act has been utilized periodically since the Korean War to impose
24	price controls, regulate production, develop new technologies, compel disclosure of
25	

1	information, and compel the provision of essential services during national emergencies
2	including wars and natural disasters; and
3	WHEREAS, on March 18, 2020, the President announced his intention to invoke the
4	Defense Production Act to expand production of essential medical supplies in response to the
5	COVID-19 pandemic; and
6	WHEREAS, According to the President's statements on Twitter as of March 24, 2020,
7	his administration has not yet utilized the Act to compel companies to produce essential
8	protective gear and medical devices; and
9	WHEREAS, The President's statements contradict those of the Federal Emergency
10	Management Agency (FEMA) Administrator, who claims the Administration is using the Act to
11	compel production of face masks; and
12	WHEREAS, The President has repeatedly expressed his reluctance to exercise the
13	powers of the Act to compel private companies, and inaccurately claimed he was utilizing the
14	act, when, in fact, he was not; and
15	WHEREAS, The Speaker of the House and Senate Minority Leader have both urged
16	the President to use the powers of the Act to compel mass production and distribution of
17	critical supplies including ventilators, swabs, and personal protective equipment; and
18	WHEREAS, Our ability to minimize loss of life resulting from the COVID-19 pandemic
19	at a local, state, and national level is largely dependent on our Federal government's
20	commitment to executing the rapid expansion of public health infrastructure necessary to
21	provide adequate medical care to all who contract COVID-19; and
22	WHEREAS, In 2018, over 27 million people living in the US did not have health
23	insurance; and

1	WHEREAS, Individuals without health insurance frequently delay seeking medical
2	care, or decline to seek it at all, due to prohibitively expensive costs and the potential of
3	incurring crushing debt; and
4	WHEREAS, For the purposes of minimizing loss of life and the spread of the virus, it is
5	essential that anyone who may have contracted COVID-19 immediately seek medical advice
6	and care; and
7	WHEREAS, It is unclear based on conflicting accounts provided by the President and
8	his Administration whether they are using the powers of the Act, and if so, to what extent;
9	now, therefore, be it
10	RESOLVED, That the San Francisco Board of Supervisors hereby urges the President
11	to exercise the full powers of the Defense Production Act to compel all capable private
12	companies to produce COVID-19 tests, face masks, ventilators, and other essential medical
13	devices; and, be it
14	FURTHER RESOLVED, That the San Francisco Board of Supervisors hereby urges
15	the President to exercise the full powers of the Defense Production Act to compel insurance
16	and healthcare providers to provide healthcare, free of cost, for all uninsured individuals for
17	the duration of the COVID-19 emergency; and, be it
18	FURTHER RESOLVED, That the San Francisco Board of Supervisors hereby urges
19	the President to exercise the full powers of the Defense Production Act to compel insurance
20	and healthcare providers to provide healthcare, free of cost-sharing, for all insured individuals
21	for the duration of the COVID-19 emergency.
