Good afternoon Linda,

Thank you for your email regarding the Retroactive Accept/Expend Grant for the Sheriff's Office.

The Sheriff's Office is requesting <u>retroactive</u> approval because the state increased the grant amount beyond what was foreseen during the FY2019-20 budget process. Specifically:

For fiscal year FY2019-20, SHF budgeted an amount for this grant based the budget amount on the state's prior-year, FY2018-19. The FY2018-19 grant amount of \$268,120 was based on:

- \$420.00 for each eligible budgeted position that will require Annual Training, and
- \$630.00 for each eligible budgeted position that will require Core Training

In September 2019, after the close of the City's budget process, the state notified SHF that, "due to an increase in the fiscal year state budget," the grant amount for FY2019-20 would be \$365,700 based on increased amounts per position as follows:

- \$600.00 for each eligible budgeted position that will require Annual Training, and
- \$900.00 for each eligible budgeted position that will require Core Training

Because the state increased the grant amount beyond what was foreseen during the FY2019-20 budget process, *retroactive* approval is necessary for the Sheriff's Office to accept/expend the grant.
