11 WHEREAS, Upon completion of a competitive selection process, the Airport
12 Commission adopted Resolution No. 19-0244 on October 1, 2019, awarding the Airport
13 Harvey Milk Terminal 1 Boarding Area C Food and Beverage Kiosk Lease, A Small Business
14 Set-Aside to Park Café Group, Inc.; and

15 WHEREAS, Harvey Milk Terminal 1 Boarding Area C Food and Beverage Kiosk Lease,
16 A Small Business Set-Aside, has a term of 10 years with an initial minimum annual guarantee
17 of \$240,000; now, therefore, be it

18 RESOLVED, That this Board of Supervisors hereby approves The Harvey Milk
19 Terminal 1 Boarding Area C Food and Beverage Kiosk Lease, A Small Business Set-Aside,
20 a copy of which is on file with the Clerk of the Board of Supervisors in File No. 191209; and,
21 be it

22 FURTHER RESOLVED, That within 30 days of the lease being fully executed by all
23 parties, the Airport Commission shall provide the final lease to the Clerk of the Board for
24 inclusion into the official file.


