The Federal Aviation Administration will administer the CARES Act funds. The \$254,780,449 in CARES Act funds allocated to the Airport may be used for any purpose, for which airport revenues may lawfully be used. The Airport will distribute these CARES Act funds on a reimbursement basis for eligible expenditures incurred on or after January 20, 2020. The Airport expects to expend this CARES Act funding for any lawful airport purpose.			
As a requirement for receiving CARES Act funds, the Airport must continue to employ through December 31, 2020, at least 90% of the number of individuals employed (after making adjustments for retirements or voluntary employee separations) as of March 27, 2020, the date of enactment of the CARES Act.
