3	Resolution urging California Governor Gavin Newsom to issue a moratorium on
4	evictions, including Ellis Act evictions during the state of emergency related to the
5	COVID-19 coronavirus.

7	WHEREAS, On February 25, 2020, Mayor London Breed declared a state of
8	emergency in San Francisco based on coronavirus (COVID-19); and
9	WHEREAS, On March 4, 2020, California Governor Gavin Newsom issued a
10	proclamation of a State of Emergency based on COVID-19; and
11	WHEREAS, On March 6, 2020, the San Francisco Department of Public Health issued
12	Recommendations to Reduce the Spread of the Coronavirus, which advise that vulnerable
13	populations should limit outings, and non-essential large gatherings should be cancelled or
14	postponed, among other recommendations; and
15	WHEREAS, On March 10, 2020 an ordinance was introduced, on file with the Clerk of
16	the Board of Supervisors in File No. 200267, which prohibits evictions during the Coronavirus
17	state of emergency for nonpayment of rent if the tenant demonstrates that inability to pay rent
18	is due to coronavirus, the state of emergency regarding coronavirus, or following government-
19	recommended coronavirus precautions; or for a no-fault reason unless the eviction is
20	necessary for the health and safety of the tenant or landlord; and
21	WHEREAS, On March 11, 2020, the San Francisco Health Officer issued a Declaration
22	of Local Health Emergency, Order No. C19-05; and
23	WHEREAS, On March 12, 2020, the Governor issued Executive Order N-25-20
24	ordering that residents heed the orders of state and local public health officials, including but
25	not limited to the imposition of social distancing measures; and

1 WHEREAS, On March 13, 2020, the Health Officer issued Order No. C19-05b 2 (revised), Declaration of Local Health Emergency in the City and County of San Francisco; 3 and 4 WHEREAS, On March 13, 2020, Mayor Breed issued a directive banning certain 5 nonpayment evictions arising from COVID-19 and the state of emergency; and 6 WHEREAS, On March 23, 2020, Mayor Breed issued a directive prohibiting certain no-7 fault evictions arising from COVID-19 and the state of emergency, with the exception of Ellis 8 Act evictions; and 9 WHEREAS, On March 16, 2020, the Health Officer issued Order No. C19-07, directing 10 all individuals living in the county to shelter at their place of residence except that they may 11 leave to provide certain essential services or engage in certain essential activities and work 12 for essential business and government services (shelter in place); and 13 WHEREAS, On March 16, 2020, the Governor issued Executive Order N-28-20 14 suspending state laws that would pre-empt or otherwise restrict a local government's power to 15 impose substantive limitations on residential or commercial evictions where the basis for the 16 eviction is nonpayment of rent arising from substantial decrease in household or business 17 income or substantial out of pocket medical expenses, caused by the COVID-19 pandemic of 18 any local, state, or federal response; and 19 WHEREAS, Unlawful Detainers are summary legal proceedings that can require 20 response in as little as five days, and trial within one month; and 21 WHEREAS, Unlawful detainer court proceedings require the physical presence of 22 tenants at San Francisco Superior Court at mandatory settlement conferences and trial, as 23 well as the potential presence of tenants at depositions, mediations or other out of court 24 proceedings; and

1	WHEREAS, California's Ellis Act authorizes eviction in certain situations, but such state
2	laws are waivable by Governor Newsom during a state of emergency; now, therefore, be it
3	RESOLVED, That the San Francisco Board of Supervisors Urges Governor Newsom to
4	expand his Executive Order to impose a moratorium on all evictions, with limited exception for
5	tenants posing a serious danger to the safety of others, during this state of emergency; and
6	be it
7	FURTHER RESOLVED, That the Board of Supervisors urges Governor Newsom to
8	specifically waive and suspend the provisions of the California Ellis Act, including any
9	proceedings to enforce eviction under the Ellis Act, for the period of the state of emergency;
10	and be it
11	FURTHER RESOLVED, That the Clerk of the Board of Supervisors, upon passage of
12	this Resolution, shall transmit copies of this resolution to Governor Newsom.
