3 **Motion revising the 2020 Board of Supervisors Regular Meeting Schedule pursuant to**
4 **Board of Supervisors Rules of Order, Sections 4.2 and 4.2.1, by partially rescinding the**
5 **approval to cancel all Regular Board of Supervisors and Committee meetings during**
6 **the summer break, only cancelling Regular Board and Committee meetings from**
7 **August 1, 2020, through August 7, 2020, and reauthorizing Board and Committee**
8 **meetings to meet between August 8, 2020, through September 7, 2020.**

10 WHEREAS, On December 17, 2019, the Board of Supervisors approved Motion No.
11 M19-191, establishing the 2020 Board of Supervisors Regular Meeting Schedule; and

12 WHEREAS, On February 25, 2020, Mayor London N. Breed declared the existence of
13 a local emergency relating to the COVID-19 virus; and

14 WHEREAS, On March 19, 2020, in response to the worldwide COVID-19 health
15 emergency pandemic, Governor Gavin Newsom ordered a statewide Shelter-in-Place Order
16 to reduce the spread of the virus; and

17 WHEREAS, The health emergency delayed many legislative processes and actions,
18 including approval of the annual Budget; and

19 WHEREAS, To accommodate the delayed processes, the Board must cancel a portion
20 of their legislative summer break to hold hearings and consider necessary legislative
21 approvals to ensure the continuation of business for the City and County of San Francisco;
22 now, therefore, be it

23 MOVED, That the Board of Supervisors of the City and County of San Francisco
24 hereby rescinds the approval to cancel all Board and Committee meetings between August 8,
25 2020, through September 7, 2020; and, be it

1 FURTHER MOVED, That the summer break shall be held between August 1, 2020,
2 through August 7, 2020, only; and, be it

3 FURTHER MOVED, That all Board and Committee meetings are reauthorized to hold
4 regular meetings between August 8, 2020, through September 7, 2020; and, be it

5 FURTHER MOVED, Pursuant to Board Rule 4.3, the Board is constrained by certain
6 administrative, electoral, and legislative deadlines and may schedule Special Meetings when
7 necessary to conduct the City's business.
