10 Superior Court, Court No. 436930, as it relates only to co-plaintiffs Pat/Tom Moore, by the
11 payment of \$120,000, and excluding the claim by these plaintiffs for diminution of property
12 value, attorney's fees, costs and interest, which will be addressed in later proceedings.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiffs
15 Pat/Tom Moore and Defendant City and County of San Francisco.






