Enclosed is the resolution that would designate *The San Francisco Examiner* as the City's official newspaper for all Advertising for Fiscal Year 20-21.

The Office of Contract Administration (OCA) received and evaluated two (2) bids for its formal and competitive solicitation for Official Advertising. This year's competitive solicitation was advertised as a multiple-awards bid for a Primary and Secondary Contractor, to ensure the City's need for continuous Official Advertising. Upon evaluation, OCA is recommending award to the only responsive and responsible bidder. A "responsive" bidder is one who submits a bid with all required documentation by the due date and time as specified in a solicitation. Additionally, a "responsible" bidder is one who meets all the qualifications and requirements as specified in a solicitation. As seen in the attached table, "Summary of Official Advertising Bids for Fiscal Year 2020 - 2021," The San Francisco Examiner submitted the only responsive and responsible bid, which is also the lowest bid for official advertising. The San Francisco Chronicle's bid was deemed not responsible because it is not printed in San Francisco, a qualification set forth in San Francisco Administrative Code 2.80. In addition, the San Francisco Chronicle's bid price is higher than The San Francisco Examiner's bid. The proprietors of printing services have been increasingly moving their facilities out of the City. OCA policy dictates that we officially recommend only responsive and responsible bidders for contract awards but the Board of Supervisors has historically used its discretion to award the Official Advertising contract to multiple bidders to best serve the City's official advertising needs.

The total estimated contract value for official advertising for Fiscal Year 2020 - 2021 is \$400,000.

Background: Official & Outreach Advertising

- In 1994 voters passed Proposition J, mandating the Office of Contract Administration (OCA) to bid out advertising services annually, per Administrative Code 2.81 through 2.81-4
- The City is required to publicly post notices of government business, in newspapers that are locally published and printed
- Every year OCA conducts the bids and presents award recommendations based on Administrative Code mandated evaluation guidelines.
- OCA processes the bidding and contracts on the behalf of the Clerk of the Board.
- The Board of Supervisors makes the official awards by designating contracts for the Official and Outreach Advertising



Minimum Requirements, per Administrative Code 2.81-2.81-4

Official Newspaper

- ✓ Print in San Francisco on three or more days in a calendar week
- ✓ Circulation of at least 50,000 copies per calendar week

Outreach Newspapers

- ✓ Print in San Francisco on one or more days in a calendar week
