Said determination is on file with the Clerk of 14 15 the Board of Supervisors in File No. 200510 and is incorporated herein by reference. The Board affirms this determination. 16 17 Section 2. The Board of Supervisors hereby submits to the qualified voters of the City 18 and County, at an election to be held on November 3, 2020, a proposal to amend the Charter of 19 20 the City and County by revising Sections 3.104, 4.130, 16.129, and F1.102, and adding Sections 4.116, 4.138, and 4.139, to read as follows: 21 22 NOTE: Unchanged Charter text and uncodified text are in plain font. 2	SEC. 3.104. CITY ADMINISTRATOR.
3	* * * *
4	The City Administrator shall have power to:
5	6. With the concurrence of the Mayor, appoint and remove the directors of the
6	Departments of Administrative Services, Solid Waste, and Public Guardian/Administrator, and
7	Public Works, and such other department heads which are placed under his or her direction;
8	* * * *
9	SEC. 4.130. DEPARTMENT OF PUBLIC WORKS.
10	Except as otherwise specified in the Charter, including in Section 4.139(b)(6), The duties
11	and functions of the Department of Public Works shall design, build, and improve the City's
12	infrastructure and public right of way, and assume any other duties be-assigned by the City
13	Administrator, by ordinance or pursuant to Section 4.132. The Department shall be headed by
14	the Director of Public Works, who shall be qualified by either technical training or management
15	experience in engineering or architecture.
16	SEC. 4.116. PUBLIC WORKS COMMISSION.
17	(a) <b>Purpose.</b> There is hereby established a Public Works Commission. The
18	Commission shall set policy directives and provide oversight for the Department of Public
19	<u>Works.</u>
20	(b) Membership and Terms of Office.
21	(1) The Commission shall consist of five members, appointed as follows:
22	Seats 1 and 5 shall be appointed by the Board of Supervisors. Seat 1 shall be held
23	by a registered professional engineer licensed in the State of California, with a background in
24	civil, mechanical, or environmental engineering, and program management, and Seat 5 shall be
25	an at-large position.

1	Seats 2 and 4 shall be appointed by the Mayor subject to confirmation by the
2	Board of Supervisors. Each nomination shall be the subject of a public hearing and vote within
3	60 days. If the Board of Supervisors fails to act on a nomination within 60 days of the date the
4	nomination is transmitted to the Clerk of the Board of Supervisors, the nominee shall be deemed
5	confirmed. Seat 2 shall be held by a registered architect licensed in the State of California, and
6	Seat 4 shall be an at-large position.
7	Seat 3 shall be held by a person with a background in finance with at least 5
8	years in auditing experience, appointed by the Controller subject to confirmation by the Board of
9	Supervisors. The nomination shall be the subject of a public hearing and vote within 60 days. If
10	the Board of Supervisors fails to act on a nomination within 60 days of the date the nomination is
11	transmitted to the Clerk of the Board of Supervisors, the nominee shall be deemed confirmed.
12	(2) Members of the Commission shall serve four-year terms; provided,
13	however, the term of the initial appointees in Seats 1, 3, and 5 shall be two years.
14	(3) Commissioners may be removed from office at will by their respective
15	appointing authority.
16	(c) Powers and Duties.
17	(1) With regard to the Department of Public Works, beginning on September
18	1, 2021, the Commission shall exercise all the powers and duties of boards and commissions set
19	forth in Sections 4.102, 4.103, and 4.104, and may take other actions as prescribed by
20	ordinance.
21	(2) The Commission shall oversee the Department's performance, including
22	evaluation of data collected by the Department, the Controller, and other City agencies.
23	(3) The Commission shall approve all contracts proposed to be entered into
24	by the Department, provided that the Commission may delegate this responsibility to the
25	Director of Public Works, or the Director's designee.

1	(4) The Commission may require the Director of Public Works, or the
2	Director's designee, to provide the Commission with proof of adequate performance of any
3	contract entered into by the Department, based on written documentation including
4	documentation that work has been inspected and approved by the appropriate City departments
5	<u>or officers.</u>
6	(5) The Commission shall perform an annual review on the designation and
7	filling of Department positions, as exempt, temporary, provisional, part-time, seasonal or
8	permanent status, the number of positions that are vacant, and at the Commission's discretion,
9	other data regarding the Department's workforce. This function shall not in any way limit the
10	roles of the Civil Service Commission or the Department of Human Resources under the
11	<u>Charter.</u>
12	(d) Transition provisions.
13	(1) The Mayor, Board of Supervisors, and Controller shall make initial
14	appointments to the Commission by no later than noon on June 1, 2021. The Commission shall
15	come into existence on either June 1, 2021 at noon, or noon of the date that three members of the
16	Commission have assumed office, whichever is later. The terms of all five members shall
17	commence at noon on June 1, 2021, regardless of when the Commission comes into existence.
18	(2) The Commission shall have its inaugural meeting by no later than
19	<u>September 1, 2021.</u>
20	(3) The Director of Public Works at the time the Commission comes into
21	existence shall remain in that position unless removed from it in accordance with the Charter
22	provisions governing removal of a department head serving under a commission. If a person is
23	serving in an acting capacity as Director at the time the Commission comes into existence, the
24	preceding sentence applies, except that the position shall also be considered vacant for purposes
25	of the next sentence. If the position of Director is vacant for any reason, including removal of

1	the incumbent Director, the position shall be filled in accordance with the Charter provisions
2	governing appointment of a department head serving under a commission. In that event, a
3	person removed from the position under the first sentence of this subsection may be considered
4	for appointment to the position.
5	
6	SEC. 4.138. SANITATION AND STREETS COMMISSION.
7	(a) <b>Purpose.</b> There is hereby established a Sanitation and Streets Commission. The
8	Commission shall set policy directives and provide oversight for the Department of Sanitations
9	and Streets.
10	(b) Membership and Terms of Office.
11	(1) The Commission shall consist of five members, appointed as follows:
12	Seats 1 and 2 shall be appointed by the Mayor subject to confirmation by the
13	Board of Supervisors. Each nomination shall be the subject of a public hearing and vote within
14	60 days. If the Board of Supervisors fails to act on a nomination within 60 days of the date the
15	nomination is transmitted to the Clerk of the Board of Supervisors, the nominee shall be deemed
16	confirmed. Seat 1 shall be held by a person who is a small business owner. Seat 2 shall be held
17	by a person with experience in project management.
18	Seat 3 shall be appointed by the Controller subject to confirmation by the Board
19	of Supervisors. The nomination shall be the subject of a public hearing and vote within 60 days.
20	If the Board of Supervisors fails to act on a nomination within 60 days of the date the nomination
21	is transmitted to the Clerk of the Board of Supervisors, the nominee shall be deemed confirmed.
22	Seat 3 shall be held by a person who has a background in finance and audits.
23	Seats 4 and 5 shall be appointed by the Board of Supervisors. Seat 4 shall be held
24	by a person who has a background in either urban forestry, urban design, or environmental
25	

1	services. Seat 5 shall be held by a person with significant experience in cleaning and
2	maintaining public spaces.
3	(2) Members of the Commission shall serve four-year terms; provided,
4	however, the term of the initial appointees in Seats 1 and 4 shall be two years.
5	(3) Members may be removed at will by their respective appointing officer.
6	(c) <b>Duties.</b> With regard to the Department of Sanitation and Streets, beginning on
7	three months after the Transition Date in subsection (d), the Commission shall exercise all the
8	powers and duties of boards and commissions set forth in Sections 4.102, 4.103, and 4.104, and
9	may take other actions as prescribed by ordinance. In addition, the Commission shall:
10	(1) review and evaluate data regarding street and sidewalk conditions,
11	including but not limited to data collected by the Department, and annual reports generated by
12	the Controller;
13	(2) establish minimum standards of cleanliness for the public right of way,
14	and set baselines for services to be administered by the Department;
15	(3) approve all contracts proposed to be entered into by the Department,
16	provided that the Commission may delegate this responsibility to the Director of the Department,
17	or the Director's designee;
18	(4) perform an annual cost analysis evaluating whether there are
19	inefficiencies or waste in the Department's administration and operations; and
20	(5) perform an annual review on the designation and filling of Department
21	positions, as exempt, temporary, provisional, part-time, seasonal or permanent status, the
22	number of positions that are vacant, and at the Commission's discretion, other data regarding
23	the Department's workforce. This function shall not in any way limit the roles of the Civil
24	Service Commission or the Department of Human Resources under the Charter.
25	(d) Transition provisions.

1	(1) The Commission shall come into existence on the Transition Date, which
2	shall be either July 1, 2022 at noon or an earlier date established by the Board of Supervisors by
3	written motion adopted no later than January 1, 2022. The Mayor, Board of Supervisors, and
4	Controller shall make initial appointments to the Commission by no later than three months
5	before the Transition Date. The terms of all five members shall commence at noon on the
6	Transition Date.
7	(2) The Commission shall have its inaugural meeting by no later than 30 days
8	after three members of the Commission have assumed office.
9	(3) The Director of Public Works or person serving in an acting capacity as
10	Director of Public Works, at the time the Commission comes into existence, shall perform the
11	duties of the Director of the Department of Sanitation and Streets in an acting capacity until the
12	Commission appoints a new Director in accordance with the Charter provisions governing
13	appointment of a department head serving under a commission.
14	
15	SEC. 4.139. DEPARTMENT OF SANITATION AND STREETS.
16	(a) <b>Establishment.</b> There shall be a Department of Sanitation and Streets, which
17	shall come into existence three months after the date the Transition Date for the Sanitation and
18	Streets Commission in Section 4.138(d). The Department shall be headed by the Director of
19	Sanitation and Streets, who shall be qualified by either technical training or management
20	experience in environmental services or the maintenance, sanitation, or cleaning of public
21	spaces; and shall have a demonstrated knowledge of best practices regarding cleaning and
22	maintenance of high-traffic or publicly accessible areas. The Department shall assume all
23	responsibilities previously under the jurisdiction of the Department of Public Works that pertain
24	to the duties specified in subsection (b).
25	

Supervisors Haney; Ronen, Walton, Preston, Mar **BOARD OF SUPERVISORS** 

1	(b) <b>Duties.</b> Except as otherwise provided in the Charter or pursuant to Section
2	4.132, in addition to any other duties assigned by ordinance, the Department shall have the
3	following duties:
4	(1) efficient and systematic street sweeping, sidewalk cleaning, maintenance
5	and cleaning of public restrooms in the public right of way, and litter abatement;
6	(2) provision and maintenance of city trash receptacles;
7	(3) removal of illegal dumping and graffiti in the public right of way;
8	(4) maintenance of public medians, and of street trees in the public right of
9	way pursuant to section 16.129;
10	(5) maintenance of City streets and sidewalks;
11	(6) construction, repair, remodeling, and management services for City-
12	owned buildings and facilities; and
13	(7) control of pests on City streets and sidewalks.
14	The Board of Supervisors may limit, modify, or eliminate the duties set forth in
15	subsections (1) through (7), and may transfer any of those duties to the Department of Public
16	Works or other City departments, by ordinance approved by two-thirds of the Board.
17	(c) <b>Performance of Work for Other Departments.</b> No department may enter
18	agreements with private parties for public works or improvements in City streets, sidewalks, or
19	City-owned buildings or facilities, unless the department first requests the Department of
20	Sanitation and Streets to perform the work subject to specifications and timing requirements
21	determined in the discretion of the requesting department.
22	(d) Administrative Support. The Board of Supervisors may by ordinance require the
23	City Administrator, the Department of Public Works, and/or any other City department to
24	provide administrative support for the Department, which may include but need not be limited to
25	

1	human resources, performance management, finance, budgeting, technology, emergency
2	planning, training, and employee safety services.
3	(e) Transition.
4	No later than July 1, 2021, the City Administrator shall submit to the Board of
5	Supervisors a proposed ordinance amending the Municipal Code, including but not limited to the
6	Public Works Code, to conform to Sections 3.104, 4.116, 4.130, , 4.138, 16.129, F1.102, and this
7	Section 4.139, as adopted or amended by the voters at the November 3, 2020 election.
8	
9	SEC. 16.129. STREET TREE MAINTENANCE.
10	(a) Definitions. For purposes of this Section 16.129:
11	* * * *
12	"Maintenance" (and its root "Maintain") shall mean those actions necessary to
13	promote the life, growth, health, or beauty of a Tree. Maintenance includes both routine
14	maintenance and major maintenance. Routine maintenance includes adequate watering to ensure
15	the Tree's growth and sustainability; weed control; removal of Tree-well trash; staking;
16	fertilizing; routine adjustment and timely removal of stakes, ties, Tree guards, and Tree grates;
17	bracing; and Sidewalk repairs related to the Tree's growth or root system. Major maintenance
18	includes structural pruning as necessary to maintain public safety and to sustain the health,
19	safety, and natural growth habit of the Tree; pest and disease-management procedures as needed
20	and in a manner consistent with public health and ecological diversity; and replacement of dead
21	or damaged Trees. Pruning practices shall be in compliance with International Society of
22	Arboriculture Best Management Practices and ANSI Pruning Standards, whichever is more
23	protective of Tree preservation, or any equivalent standard or standards selected by the Director
24	of the Department of <i>Sanitation and Streets</i> Public Works.
25	* * * *

1	"Street Tree" shall mean any Tree growing within the public right-of-way, including
2	unimproved public streets and Sidewalks, and any Tree growing on land under the jurisdiction of
3	the Department of Public Works or the Department of Sanitation and Streets. "Street Tree" does
4	not include any other forms of landscaping.
5	* * * *
6	(g) Beginning in fiscal year 2018-2019, the City may suspend growth in the City's \$19
7	million contribution to the Fund under subsection (f) of this Section 16.129 if the City's
8	projected budget deficit for the upcoming fiscal year at the time of the Joint Report or Update to
9	the five-year financial plan as prepared jointly by the Controller, the Mayor's Budget Director,
10	and the Board of Supervisors' Budget Analyst exceeds \$200 million adjusted annually by
11	changes in aggregate discretionary revenues as defined in subsection (f) of this Section 16.129.
12	(h) Administration and Use of the Fund. The Department of <i>Sanitation and</i>
13	Streets Public Works shall administer the Fund. Monies in the Fund shall only be used for the
14	following purposes:
15	(1) Maintenance and Removal of Street Trees;
16	(2) Necessary costs of administering the Fund; and
17	(3) Making grants totaling up to \$500,000 annually to the San Francisco Unified
18	School District exclusively to fund Maintenance and Removal of Trees on School District
19	property.
20	* * * *
21	(i) Annual Reports. Commencing with a report filed no later than January 1, 2019,
22	covering the fiscal year ending June 30, 2018, the Department of Sanitation and Streets Public
23	Works shall file annually with the Board of Supervisors, by January 1 of each year, a report
24	containing the amount of monies collected in and expended from the Fund during the prior fiscal
25	year, and such other information as the Director of the Department of Sanitation and

1	Streets Public Works, in the Director's sole discretion, shall deem relevant to the operation of this
2	Section 16.129.
3	* * * *
4	F1.102. STREET, SIDEWALK, AND PARK CLEANING AND MAINTENANCE.
5	(a) The Services Audit Unit shall conduct annually a performance audit of the City's
6	street, sidewalk, and public park maintenance and cleaning operations. The annual audit shall:
7	(1) Include quantifiable, measurable, objective standards for street, sidewalk,
8	and park maintenance, to be developed in cooperation and consultation with the <u>Department of</u>
9	Sanitation and Streets, the Department of Public Works, and the Recreation and Park
10	Department;
11	* * * *
12	(b) The Services Audit Unit shall conduct annually a cost and waste analysis evaluating
13	whether there are inefficiencies or waste in the administration and operations of the Department
14	of Sanitation and Streets, and the Department of Public Works or inefficiencies or waste in the
15	division of labor between the two departments. The annual audit shall make quantifiable,
16	measurable recommendations for the elimination of inefficient operations and functions, and
17	shall include:
18	(1) Consolidation of duplicative and overlapping activities and functions;
19	(2) Integration and standardization of information maintenance systems that
20	promote interdepartmental sharing of information and resources;
21	(3) Departmental accounting for expenditure of resources in terms of effectiveness
22	of the service or product delivered;
23	(4) Departmental deployment and utilization of personnel, the City's personnel
24	procurement system, and reforms to enhance the quality of work performance of public
25	employees; and

1	(5) <i>Methods of operation to reduce consumption and waste of resources.</i>
2	(bc) In addition, all City agencies engaged in street, sidewalk, or park maintenance
3	shall establish regular maintenance schedules for streets, sidewalks, parks and park facilities,
4	which shall be available to the public and on the department's website. Each such department
5	shall monitor compliance with these schedules, and shall publish regularly data showing the
6	extent to which the department has met its published schedules. The City Services Audit Unit
7	shall audit each department's compliance with these requirements annually, and shall furnish
8	recommendations for meaningful ways in which information regarding the timing, amount and
9	kind of services provided may be gathered and furnished to the public.

# **LEGISLATIVE DIGEST**

Revised 06/29/20

[Charter Amendment - Sanitation and Streets Department, Sanitation and Streets Commission, and Public Works Commission]

Describing and setting forth a proposal to the voters at an election to be held on November 3, 2020, to amend the Charter of the City and County of San Francisco to create the Sanitation and Streets Department to succeed to specific duties currently performed by the Department of Public Works; to create a Sanitation and Streets Commission to oversee the Sanitation and Streets Department; to create a Public Works Commission to oversee the Department of Public Works; to require an annual performance audit and cost and waste analysis for both departments; and affirming the Planning Department's determination under the California Environmental Quality Act.

#### Existing Law

Under the Charter, the Department of Public Works' responsibilities are determined by the City Administrator and include the responsibility for maintaining and cleaning the public right of way.

Charter section 4.102 provides that a commission of the executive branch has the responsibility to formulate, evaluate and approve goals, set policies, develop Annual Statements of Purpose for the departments under its jurisdiction, and approve departmental budgets.

Charter section F1.102 provides that the City Auditor shall develop quantifiable, measurable, objective standards for street, sidewalk, and park maintenance in consultation with the Department of Public Works.

## Amendments to Current Law

This Charter amendment would remove the Department of Public Works from the purview of the City Administrator. The amendment would create a new Public Works Commission which would have oversight over the Department of Public Works. At the same time, the responsibilities for cleaning and maintaining the public right of way, and certain other responsibilities such as the maintenance of street trees in the public right of way would be transferred to a newly created Department of Sanitation and Streets. The new Department would also be responsible for maintaining City buildings. The amendment would also create a Sanitation and Streets Commission which would have oversight responsibilities over the new Department of Sanitation and Streets. The new Department and Commission would have a focus on street cleaning, including measurement of the City's performance using objective metrics. Street cleaning would include the deep cleaning of sidewalks using methods such as

power washing. The Charter amendment would also require the Controller's office to complete an annual performance audit and cost and waste analysis for both departments.
