10 WHEREAS, SoMa Wines and Spirits Inc., is seeking the premise-to-premise  
11 transfer of a Type-21 off-sale general beer, wine, and distilled spirits liquor license to do  
12 business as East Cut Traders, located at 301 Howard Street, Suite 120 (District 6); and

13 WHEREAS, The Planning Department has verified that the area is properly  
14 zoned and recommends approval; and

15 WHEREAS, The Police Department has filed zero protests and zero letters of  
16 support with the Department of Alcoholic Beverage Control under California Business  
17 and Professions Code, Section 24013, and recommends that the Department of  
18 Alcoholic Beverage Control issue the liquor license with conditions; and

19 WHEREAS, The condition recommended by the Police Department is the  
20 following: 1) Petitioner(s) shall actively monitor the area under their control in an effort  
21 to prevent the loitering of persons on any property adjacent to the licensed premises as  
22 depicted on the most recently certified ABC-253; now, therefore, be it

23 RESOLVED, That in accordance with California Business and Professions Code,  
24 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
25 hereby determines that the premise-to-premise transfer of a Type-21 off-sale general

1 beer, wine, and distilled spirits liquor license to SoMa Wines and Spirits Inc., doing  
2 business as East Cut Traders, located at 301 Howard Street, Suite 120, will serve the  
3 public convenience or necessity of the City and County of San Francisco; and, be it

4 FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
5 San Francisco hereby endorses and adopts the recommendations of the Police  
6 Department listed above and recommends that the Department of Alcoholic Beverage  
7 Control issue the license with those conditions.
