SUBJECT: LEGISLATION INTRODUCED

The Board of Supervisors' Government Audit and Oversight Committee has received the following proposed legislation, introduced by Supervisor Peskin on July 7, 2019:

Ordinance amending the Administrative Code to require Public Works to adhere to the Environment Code and provisions requiring competitive bidding, equal benefits, local business enterprise utilization, and other requirements for construction work and professional and other services relating to projects addressing homelessness; and requiring the Department of Homelessness and Supportive Housing to engage in competitive bidding for professional and other services relating to sites and programs for people experiencing homelessness.

17	Section 1. Chapter 6 of the Administrative Code is hereby amended by deleting		
18	Section 6.76, to read as follows:

20	SEC. 6.76. PUBLIC WORKS ADDRESSING HOMELESSNESS.		
21	- (a) The Department of Public Works is authorized to enter into and/or amend any contract		
22	for any Public Work or Improvement, as defined in Administrative Code Section 6.1, including any		
23	professional services for a Public Work or Improvement, without adherence to the requirements of this		
24	Chapter 6, Administrative Code Chapters 12B and 14B, and the Environment Code; provided,		
25	however, that the Public Work or Improvement is for the construction, repair, or improvement of one or

1	more sites that will be used for the primary purpose of providing housing, shelter, or services to people
2	experiencing homelessness. The power to amend such contracts extends to contracts entered into prior
3	to the effective date of the ordinance in Board File No. 190047 enacting this Chapter 21B.
4	(b) This Section 6.76 shall expire by operation of law five years from its effective date, or on
5	the effective date of an ordinance making the finding that according to the most recent Point in Time
6	Homeless Count, there are fewer than 5,250 homeless persons in San Francisco, whichever date is
7	earlier. Upon expiration of this Section 6.76, the City Attorney shall cause this Section to be removed
8	from the Administrative Code.

10	Section 2. Chapter 21 of the Administrative Code is hereby amended by deleting
11	Chapter 21B, to read as follows:

14	COMMODITIES AND SERVICES RELATING TO PROJECTS ADDRESSING

17	SEC. 21B.1. PURPOSE AND GOALS.
18	-In recognition of the fact that a significant number of persons within San Francisco lack the
19	ability to obtain shelter, resulting in a threat to the health and safety of those persons, and that such
20	threat constitutes a shelter crisis, the intent of this Chapter 21B is to expedite the procurement of
21	professional and other services relating to Projects Addressing Homelessness . For purposes of this
22	Chapter 21B, "Projects Addressing Homelessness " means projects designed to prevent homelessness
23	through the provision of housing subsidies or other services, and projects designed to provide shelter,
24	housing, food, and/or social services to people experiencing homelessness.

SEC. 21B.2. WAIVER OF COMPETITIVE BIDDING REQUIREMENTS.

2	-Notwithstanding Section 21.1 of the Administrative Code or any other provision of the
3	Municipal Code, the Department of Public Works and the Department of Homelessness and Supportive
4	Housing may enter into and/or amend contracts, including grants, for professional and other services
5	or commodities relating to Projects Addressing Homelessness without adhering to the requirements of
6	Section 21.1 or any other competitive procurement requirements. The power to amend such contracts
7	and grants extends to contracts and grants entered into prior to the effective date of the ordinance in
8	Board File No. 190047 enacting this Chapter 21B.
9	
10	SEC. 21B.3. REPORTING.
11	-Within one year of the effective date of this Chapter 21B, and every year thereafter, the
12	Department of Homelessness and Supportive Housing and the Department of Public Works shall
13	submit to the Board of Supervisors a report that includes the following information for each contract or
14	grant that the department executed during the prior year without adhering to the requirements of
15	Section 21.1, pursuant to the authority in this Section 21B.3: the name of the contractor or grantee; the
16	services to be provided under the contract or grant; the amount of funds conveyed; the duration of the
17	contract or grant; and any measurable outcomes of the contract or grant.
18	
19	SEC. 21B.4. SUNSET PROVISIONS.
20	- This Chapter 21B shall expire by operation of law five years from its effective date, or on the
21	effective date of an ordinance making the finding that according to the most recent Point in Time
22	Homeless Count, there are fewer than 5,250 homeless persons in San Francisco, whichever date is
23	earlier. Upon expiration of this Chapter 21B, the City Attorney shall cause this Chapter to be removed
24	from the Administrative Code.

1	Section 3. Effective Date. This ordinance shall become effective 30 days after				
2	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the				
3	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board				
4	of Supervisors overrides the Mayor's veto of the ordinance.				
5					
6	Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors				
7	intends to amend only those words, phrases, paragraphs, subsections, sections, articles,				
8	numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal				
9	Code that are explicitly shown in this ordinance as additions, deletions, Board amendment				
10	additions, and Board amendment deletions in accordance with the "Note" that appears under				
11	the official title of the ordinance.

LEGISLATIVE DIGEST

[Administrative Code - Eliminating Streamlined Contracting for Homeless Services]

Ordinance amending the Administrative Code to require Public Works to adhere to the Environment Code and provisions requiring competitive bidding, equal benefits, local business enterprise utilization, and other requirements for construction work and professional and other services relating to projects addressing homelessness; and requiring the Department of Homelessness and Supportive Housing to engage in competitive bidding for professional and other services relating to sites and programs for people experiencing homelessness.

Existing Law

Local Law generally requires City departments to use a competitive bidding process and follow other contracting requirements for professional services and other commodities, and construction contracts, subject to exceptions. However, since 2018, local law has established a streamlined contracting process for homeless services.

Under existing law, the Departments of Homelessness and Supportive Housing ("HSH") and Public Works may enter into and amend contracts and grants for professional or other services and commodities relating to projects addressing homelessness without using a competitive bidding process. For purposes of this authority, "projects addressing homelessness" are projects designed to prevent homelessness through the provision of housing subsidies or other services, and projects designed to provide shelter, housing, food, and/or social services to people experiencing homelessness.

Under existing law, the Department of Public Works may enter into or amend contracts for public works and improvements without using a competitive bidding process, and without adherence to the Environment Code and Administrative Code Chapters 12B and 14B, provided the contracts are for public works or improvements for the construction, repair, or improvement of one or more sites that will be used for the primary purpose of providing housing, shelter, or services to people experiencing homelessness.

The authority to enter into and amend contracts without competitive bidding and adherence to specified codes is scheduled to expire in April 2024, or on the effective date of an ordinance making a finding that according to the most recent Point in Time Homeless Count, there are fewer than 5,250 homeless persons in San Francisco, whichever date is earlier.

Amendments to Current Law

The proposed ordinance would eliminate the streamlined contracting process for agreements relating to projects addressing homelessness, and would require HSH and Public Works to

use a competitive bidding process and follow other contracting requirements for the procurement of personal and other services, commodities, and public works and improvements for projects addressing homelessness.
