3 **Ordinance authorizing settlement of the lawsuit filed by Jonathan Garcia Valle against**  
4 **the City and County of San Francisco for \$850,000; the lawsuit was filed on**  
5 **December 19, 2017, in San Francisco Superior Court, Case No. CGC-17-563210; entitled**  
6 **Jonathan Garcia Valle v. City and County of San Francisco, et al.; the lawsuit involves**  
7 **alleged personal injury from vehicle collision.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Jonathan Garcia Valle v. City and  
12 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-17-563210 by  
13 the payment of \$850,000. The lawsuit involves alleged personal injury from vehicle collision.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 December 19, 2017, and the following parties were named in the lawsuit: plaintiff Jonathan  
16 Garcia Valle; defendants City and County of San Francisco and Raymond Lee Honor.
