13	Be it ordained by the People of the City and County of San Francisco:	
14		
15	Section 1. Findings.	
16	(a) The novel coronavirus and the resulting disease COVID-19 (collectively "COVID-	
17	19") has had unprecedented detrimental effects on employees in the City and County of San	
18	Francisco ("the City"), nationwide, and worldwide. To ameliorate the local effects of this	
19	global pandemic, this ordinance extends and codifies, with minor amendments, a right to	
20	reemployment created by an emergency ordinance (Ordinance No. 104-20) for eligible laid-off	
21	employees if their prior employers seek to rehire staff. By facilitating reemployment, this	
22	ordinance aims to curb the long-term, adverse effects that job loss can cause on the financial,	
23	physical, and mental health of employees and their families and thus our greater community.	
24	(b) On February 25, 2020, Mayor London Breed proclaimed a state of emergency in	
25	response to the spread and threat of further spread of COVID-19, with which the Board of	

1 Supervisors concurred on March 3, 2020. On March 6, 2020, the Health Officer the City and 2 County of San Francisco ("Health Officer"), acting in coordination with the health officers in 3 other counties in the San Francisco Bay Area, issued a declaration of local health emergency 4 regarding COVID-19. On March 16, 2020, to mitigate the spread of COVID-19, the Health 5 Officer issued Order No. C-19-07, directing that individuals living in the City shelter in their 6 places of residence until April 7, 2020, and that businesses, except essential businesses as 7 defined in the order, cease all activities at facilities located within the City except minimum 8 basic operations, as defined in the order. The order has been extended and amended several 9 times to allow certain additional activities and businesses to resume. It remains in effect with 10 no expiration date as Order No. C-19-07f.

11 (c) Due to the public health emergency related to COVID-19 and the actions required to 12 respond to it, an unprecedented number of individuals who work for employers operating in 13 the City are unable to work (including telework) due to illness, exposure to others with the 14 coronavirus, business closures or reductions in force, and family caregiving obligations related 15 to the closure of schools and childcare facilities, including an inability to secure alternative 16 caregiving assistance. Tens of thousands of employees working in the City have been or 17 likely will be laid off from their jobs. The City has received notice of some of those layoffs, as 18 required under the federal Worker Adjustment and Retraining Notification ("WARN") Act, 29 19 U.S.C. §§ 2101-2109, and the California Worker Adjustment and Retraining Notification ("Cal-20 WARN") Act, Cal. Labor Code §§ 1400-1408. The WARN Act applies to employers with 100 21 or more employees, who were employed for six of the preceding 12 months and who worked 22 more than 20 hours per week. The WARN Act's notice requirement is generally triggered by a 23 plant closing or mass layoff affecting 50 or more employees at a single site of employment. 24 The Cal-WARN Act applies to employers that currently employ or have employed in the last 25 12 months, 75 or more full-time or part-time employees for six of the last 12 months. The Cal1 WARN Act's notice requirement is triggered by a layoff in any 30-day period of 50 or more 2 employees at a covered establishment. In the span of less than three months, between 3 March 16, 2020 and June 5, 2020, pursuant to the WARN Act and Cal-WARN Act, the City 4 has received 352 notices of layoffs that have occurred during that period by San Francisco 5 employers and that have affected 38,994 employees. An unknown number of employees of 6 San Francisco businesses that are not subject to the WARN Act of the Cal-WARN Act have 7 also been affected by layoffs due to COVID-19. This ordinance is necessary to mitigate the 8 severe, long-term economic harm for these individuals unable to work due to the public health 9 emergency.

10 (d) The COVID-19 pandemic has caused an unprecedented spike in unemployment at 11 national, state, and local levels, the likes of which the country has not seen since the Great 12 Depression of the 1930s. Nationally, in April 2020, the unemployment rate rose to 14.7%, as 13 compared to a rate of approximately 4% during the prior quarter. While the national 14 unemployment rate declined in May and June to 13.3% and 11.1%, respectively, those rates 15 are still staggering. As of July 23, 2020, workers nationwide have filed approximately 53 16 million claims for unemployment insurance at some point during the pandemic. The impact in 17 California has been especially acute. Statewide, unemployment rate was above 16% for both 18 the months of April and May 2020, and it improved slightly to 15.1% for June 2020. Between March 14 and July 18, 2020, Californians filed approximately 8.7 million claims for 19 20 unemployment insurance.

The City is similarly experiencing dramatic rates of unemployment. For April 2020, the State of California preliminarily estimated that 69,400 San Franciscans were unemployed, resulting in an unemployment rate of 12.6%. Between February 25, 2020 and May 30, 2020, approximately 141,000 San Franciscans filed claims for unemployment insurance with the State of California. As of June 18, 2020, the San Francisco Bay Area had lost over 3% of its 4.1 million jobs over the prior three months, resulting in more than 136,000 layoffs through theregion.

3 These numbers—while staggering—unfortunately fail to reflect the total impact of the 4 COVID-19 pandemic on the labor market. Traditional unemployment estimates have long 5 been critiqued for applying overly restrictive criteria to track unemployment, including the 6 requirement that the unemployed person be actively seeking work. According to the U.S. 7 Department of Labor, individuals are classified as unemployed if they do not have a job, have 8 actively looked for work in the prior four weeks, and are currently available for work. 9 Estimates, therefore, do not account for a large pool of "missing workers," also known as 10 "marginally attached" workers, defined as potential workers who, because of weak job 11 opportunities, are neither employed nor actively seeking a job. Traditional unemployment 12 metrics also fail to account for the underemployed-those who may prefer to work full-time, 13 but can only acquire part-time work. Accounting for those marginally attached and the 14 underemployed, the U.S. Department of Labor estimates the unemployment rate to be 18.0% 15 nationwide and 14.9% in California (seasonally adjusted) for June 2020. In short, the COVID-16 19 pandemic is likely having an even more detrimental effect on the job market in San 17 Francisco than estimated with traditional metrics.

Moreover, unemployment statistics, even when documenting a massive surge in joblessness, do not adequately convey the human suffering that attends joblessness on such a large scale. The loss of employment for individuals laid off as a result of the COVID-19 pandemic typically places them and their families in great economic peril. This is especially so because job losses due to the pandemic are disproportionately affecting low-wage workers, since many white-collar workers are able to continue working from home. (e) Layoffs caused by the COVID-19 pandemic also pose a substantial risk to public

25 health because layoffs can cause a loss of private health insurance benefits for affected

1 employees and their families. The loss of private health insurance during normal times-let 2 alone during a pandemic-can put insurmountable pressure on a family's fiscal, physical, and 3 mental health. While an employee may be entitled to extend health insurance benefits 4 temporarily under the Consolidated Omnibus Budget Reconciliation Act ("COBRA"), 29 U.S.C. 5 §§ 1161-68, COBRA continuation coverage is often more expensive than what the employee 6 paid for coverage while employed. A loss of one's job and the related employment benefits 7 can force a family to choose between paying for COBRA continuation coverage, paying rent, 8 or putting food on the table. This ordinance, therefore, is intended to decrease the number of 9 laid-off employees who will be without employer-sponsored health insurance as a result of the 10 COVID-19 pandemic by requiring employers subject to the ordinance to rehire eligible 11 employees if rehiring begins, thereby resuming such employees' access to their prior health 12 insurance benefits.

Layoffs caused by the COVID-19 emergency also pose a substantial risk to public health in the City by potentially forcing laid-off employees to seek out the City's public health resources, if they are not eligible for COBRA or if COBRA continuation benefits are too costly for them to secure. This ordinance, therefore, is intended to alleviate the burden that layoffs of employees covered by the ordinance are likely to have on the City's public health system.

(f) The COVID-19 pandemic has created unique challenges for caretakers, including
working parents whose children are unable to attend school, summer camp, or childcare
facilities, or whose regular caretakers are not available. The pandemic is also putting
substantial pressure on workers who must care for a family member who becomes ill due to
the novel coronavirus. These workers will have even more difficulty obtaining reemployment
following a layoff.

(g) The COVID-19 pandemic has created a substantial financial crisis for the City
 collectively and for individuals living or working in the City. The pandemic has caused a

severe nationwide recession, which may evolve into an economic depression; but regardless,
the pandemic's economic effects are likely to last well after the State and City shelter in place
orders are lifted. The loss of employment for individuals laid off as a result of the COVID-19
pandemic poses a substantial threat to the City's economy and the economic livelihood of
affected employees and their families.

After the Great Recession of 2007-2009, California's unemployment rate increased to
12% and remained above 10% for 43 consecutive months between February 2009 and
August 2012. California's long-term unemployment percentages remained significantly higher
than pre-recession rates for a decade, at 24.9% in 2017 from 16.8% in 2007.

10 For individuals and families, the loss of a job results not only in lost wages in the short 11 term, but can permanently suppress an employee's wages and earning potential for the 12 duration of the employee's working life. A National Bureau of Economic Research study of 13 workers displaced during the Great Recession of 2008-2009 found that, five years after 14 displacement, workers' earnings averaged more than \$2,000 less per quarter than the 15 earnings of comparable non-displaced workers, translating to approximately 15% lost 16 earnings. An analysis of Congressional Budget Office estimates of the U.S. Gross Domestic 17 Product over time suggests that long-term wage losses for displaced workers who previously 18 had the same job for more than three years will total more than \$1 trillion over a 20-year 19 period (or roughly \$50 billion on average annually).

Job loss also increases an individual's risk of physical and mental health problems, suicide, and homelessness, and it correlates with higher mortality rates. Finally, job loss for a parent has been shown to hamper the educational progress of the parent's children and, as a result, to suppress the future wages of those children.

These consequences from prolonged job loss are amplified by growing evidence that employers may discriminate against applicants during the hiring process for having been previously laid off, despite the absence of evidence that a prolonged period of unemployment
 diminishes a worker's productivity upon reemployment.

3 (h) Finally, this ordinance is intended to support the economic recovery of all 4 businesses operating in the City. Reemployment of laid-off employees will provide economic 5 relief directly to the affected employees and their families, giving them the opportunity to start 6 working again as soon as practicable. Reemployment aids not only an employee's own 7 personal economic recovery, but also strengthens and provides continuity for the communities in which the employee lives because the employee's resumed income will likely flow back into 8 9 local businesses that the employee can once again frequent. Such economic activity in turn 10 helps revitalize the City's economy and the greater local economy. 11 12 Section 2. The Police Code is hereby amended by adding Article 33K, to read as follows: 13 14 ARTICLE 33K: RIGHT TO REEMPLOYMENT FOLLOWING LAYOFF DUE TO COVID-15 **19 PANDEMIC** 16 SEC. 3300K.1. TITLE. This Article 33K shall be known as the "Back to Work" ordinance. 17 18 19 SEC. 3300K.2. DEFINITIONS. 20 For purposes of this Article 33K, the following terms shall have the following meanings: 21 "Beginning of the Public Health Emergency" means February 25, 2020, the date on which 22 Mayor London Breed proclaimed a state of emergency in response to the spread of the novel 23 coronavirus COVID-19. 24 "City" means the City and County of San Francisco. 25

1	"Eligible Worker" means a person: 1) who was employed by an Employer for at least 90 days
2	preceding the date on which their Employer provided written notice to the employee of a Layoff; 2) who
3	was or is Separated due to a Layoff; and 3) who provided an Employer with labor or services for
4	remuneration as an employee, as defined under California Labor Code section 2750.3, including
5	persons employed on a part-time or temporary basis, within the geographic boundaries of the City.
6	"Employer" means any person as defined in Section 18 of the California Labor Code who
7	directly or indirectly , on or after February 25, 2020, employed or employs 100 or more employees
8	worldwide, as of the earliest date that an employer Separated or Separates one or more Eligible
9	Worker that resulted or results in a Layoff. "Employer" does not include any federal, state, local, or
10	other public agency. Further, "Employer" does not include any employer that provided or provides
11	services that qualify as healthcare operations, which include, without limitation, hospitals, medical
12	clinics, diagnostic testing locations, dentists, pharmacies, blood banks and blood drives,
13	pharmaceutical and biotechnology companies, other healthcare facilities, healthcare suppliers, home
14	healthcare service providers, mental health providers, or any related and/or ancillary healthcare
15	services, as well as veterinary care and all healthcare service providers to animals.
16	"Family Care Hardship" means a circumstance in which an Eligible Worker is unable to work
17	<u>due to any reason for which an employee may use paid sick leave under Administrative Code §</u>
18	12W.4(a) to provide care for another person, including but not limited to a need to care for a child
19	whose school or place of care has been closed or whose childcare provider is unavailable as a result of
20	the Public Health Emergency and no other suitable person is available to care for the child during the
21	period of such leave. For the purpose of this definition, "child" means a biological, adopted, or foster
22	<u>child, a stepchild, a legal ward, or a child of a person standing in loco parentis, who is under 18 years</u>
23	of age or who is incapable of self-care because of a mental or physical disability.
24	"Layoff" means the Separation by an Employer of 10 or more Eligible Workers within a 30-day
25	period, starting on or after the Beginning of the Public Health Emergency, that is caused by an

1	Employer's lack of funds, lack of work, closure, or cessation of operations resulting from the Public
2	Health Emergency, including, without limitation, health orders to mitigate the spread of COVID-19.
3	"OEWD" means the Office of Economic and Workforce Development for the City.
4	"Public Health Emergency" means the state of emergency declared by the Mayor in response
5	to the novel coronavirus COVID-19.
6	"Separate" and "Separation" mean to terminate, or the termination or end of, employment,
7	respectively, by an Employer.
8	
9	SEC. 3300K.3. RECORDS REGARDING LAYOFF.
10	(a) Written Notice of Layoff and Right to Reemployment for Current Employees who are
11	Eligible Workers. When an Employer implements a Layoff on or after the effective date of this Article
12	33K, the Employer shall provide all Eligible Workers with written notice of the Layoff at or before the
13	time when the Layoff becomes effective. The Employer shall provide notice to each Eligible Worker in
14	a language understood by the Eligible Worker. The written notice shall include: a notice of the Layoff
15	and the Layoff's effective date; a summary of the right to reemployment created by this Article 33K;
16	and a telephone number for a hotline, operated by OEWD, which Eligible Workers may call to receive
17	information regarding the right to reemployment created by Ordinance No. 104-20, as extended and
18	codified by this Article 33K, as well as navigation services and other City resources related to
19	<u>unemployment.</u>
20	(b) Written Notice of Layoff and Right to Reemployment for Former Employees who are
21	Eligible Workers. If an Employer implemented a Layoff after the Beginning of the Public Health
22	Emergency, but before the effective date of this Article 33K, the Employer shall within 30 days of the
23	effective date of this Article 33K provide written notice of the Layoff, consistent with the requirements
24	for notices set forth in Section 3300K.3(a), to each Eligible Worker who the Employer Separated due to
25	

1	Layoff, unless the Employer otherwise provided notice to each Eligible Worker pursuant to Section 5 of
2	<u>Ordinance No. 104-20.</u>
3	(c) Notification to the City Regarding Layoff. An Employer shall provide written notice to
4	OEWD regarding any Layoff. The written notice shall include: the total number of Eligible Workers
5	affected by the Layoff; the job classification at the time of Separation for each Eligible Worker; the
6	original hire date for each Eligible Worker; and the date of Separation from employment for each
7	<u>Eligible Worker.</u>
8	(1) When an Employer implements a Layoff on or after the effective date of this Article
9	33K, the Employer shall provide the City with the notice within 30 days of the latest date on which it
10	<u>Separated an Eligible Worker due to a Layoff.</u>
11	(2) If an Employer implemented a Layoff after the Beginning of the Public Health
12	Emergency, but before the effective date of this Article 33K, unless the Employer otherwise provided
13	notice to the City pursuant to Section 5 of Ordinance No. 104-20, the Employer shall provide the City
14	with the notice within 30 days of the effective date of this Article 33K.
15	(d) Retention of Records. An Employer must retain the following records regarding each
16	Eligible Worker it Separated due to a Layoff for at least two years: full legal name; job classification at
17	the time of Separation; date of hire; last known address of residence; last known email address; last
18	known telephone number; and a copy of the written notice regarding the Layoff provided to the Eligible
19	Worker. For the purpose of this Section 3300K.3, two years is measured from the date of the written
20	notice provided by the Employer to the Eligible Worker, as required by subsections (a) or (b) of this
21	Section 3300K.3 or Section 5 of Ordinance No. 104-20.
22	
23	SEC. 3300K.4. EMPLOYER'S OBLIGATION TO MAKE OFFER OF REEMPLOYMENT TO
24	ELIGIBLE WORKERS FOLLOWING LAYOFF.
25	

1	(a) Offer of Reemployment Following Layoff to Same Position. Where an Employer initiated a
2	Layoff after the Beginning of the Public Health Emergency and subsequently seeks to hire a person to a
3	position located in the City that was formerly held by an Eligible Worker, the Employer shall first offer
4	the Eligible Worker an opportunity for reemployment to the Eligible Worker's former position before
5	offering the position to another person.
6	(b) Offer of Reemployment Following Layoff to Similar Position. Where an Employer initiated
7	a Layoff after the Beginning of the Public Health Emergency and subsequently seeks to hire a person to
8	any position located in the City that is substantially similar to the Eligible Worker's former position,
9	the Employer shall first offer the Eligible Worker an opportunity for reemployment to the substantially
10	similar position before offering the position to another person. For the purpose of this Section
11	3300K.4(b), a "substantially similar position" includes any of the following: a position with
12	comparable job duties, pay, benefits, and working conditions to the Eligible Worker's position at the
13	time of Layoff; any position in which the Eligible Worker worked for the Employer in the 12 months
14	preceding the Layoff; or any position for which the Eligible Worker would be qualified, including a
15	position that would necessitate training that an Employer would otherwise make available to a new
16	employee to the particular position upon hire.
17	(c) Offers of Reemployment Made in Order of Seniority. An Employer shall first make an offer
18	of reemployment under this Article 33K to the most senior Eligible Worker who formerly held that same
19	position. If the most senior Eligible Worker who formerly held the same position declines the offer of
20	reemployment, an Employer shall make subsequent offers of reemployment to any other Eligible
21	Workers who previously held the same position or any substantially similar position in order of
22	seniority. If all Eligible Workers decline the offer of reemployment, then an Employer may make such
23	offer to any person. For the purpose of this Section 3300K.4(c), the seniority of an Eligible Worker is
24	measured from their earliest date of hire by an Employer.
25	

1	(d) Exceptions. An Employer may withhold an offer of reemployment under the following
2	<u>circumstances.</u>
3	(1) Misconduct. An Employer may withhold an offer of reemployment under this Article
4	33K if, based on information learned subsequent to the Layoff of an Eligible Worker, the Employer
5	learns that an Eligible Worker engaged in any act of dishonesty, violation of law, violation of policy or
6	rule of the Employer, or other misconduct during the Eligible Worker's employment with the Employer.
7	(2) Severance Agreement. An Employer may withhold an offer of reemployment under
8	this Article 33K if the Employer and an Eligible Worker executed a severance agreement before the
9	effective date Ordinance No. 104-20 in which, in exchange for adequate consideration, the Eligible
10	Worker agreed to a general release of claims against the Employer.
11	(3) Rehiring. An Employer may withhold an offer of reemployment under this Article
12	33K if, prior to the effective date of Ordinance No. 104-20, the Employer hired a person other than the
13	Eligible Worker to the Eligible Worker's former position or to a substantially similar position, as
14	defined in Section 3300K.4(b).
15	
16	SEC. 3300K.5. NOTICE OF OFFER AND ACCEPTANCE.
17	(a) Making an Offer of Reemployment. An Employer shall engage in good faith efforts to extend
18	offers of reemployment to all Eligible Workers, consistent with the terms set forth in this Section
19	<u>3300K.5.</u>
20	(1) Electronic Delivery. An Employer shall attempt to notify an the Eligible Worker of
21	an offer of reemployment by contacting the Eligible Worker by telephone at the Eligible Worker's last
22	known telephone number and by email at the Eligible Worker's last known email address. If the
23	Employer confirms that the Eligible Worker has access to receive an offer via email, text message,
24	facsimile, or some other mode of electronic transmission, the Employer may transmit the offer
25	electronically.

1	(2) Hard Copy Delivery.
2	(A) If an Employer makes initial contact with an Eligible Worker under Section
3	3300K.5(a)(1), but the Eligible Worker is unable to receive the offer electronically, the Employer shall
4	confirm the Eligible Worker's current address of residence. The Employer shall transmit a written
5	offer of reemployment to the Eligible Worker's current address of residence by certified mail or courier
6	<u>delivery.</u>
7	(B) If an Employer is unable to make initial contact with the Eligible Worker
8	under Section 3300K.5(a)(1), the Employer shall transmit a written offer of reemployment to the
9	Eligible Worker's last known address of residence by certified mail or courier delivery. In such
10	circumstances, a courier is authorized to deliver the offer to the address of residence without obtaining
11	proof of receipt by the Eligible Worker.
12	(3) The offer shall remain open for at least two business days following delivery,
13	although the Employer may extend the acceptance period.
14	(b) Order of Delivery of Offer. Where more than one Eligible Worker is eligible for an offer of
15	reemployment, an Employer shall transmit offers to Eligible Workers in the order set forth in Section
16	<u>3300K.4(c).</u>
17	(c) Acceptance. An Eligible Worker may accept an offer of reemployment by providing a
18	response to the Employer in writing by reasonable means of delivery identified by the Employer
19	including, without limitation, returning a signed version of an offer letter or, if authorized by an
20	Employer, by applying an electronic signature and transmitting acceptance of the offer to an Employer
21	by email or other mode of electronic communication. If the Eligible Worker notifies the Employer by
22	other means, including but not limited to by telephone or text message, of the Eligible Worker's
23	acceptance of the offer, the Employer must move forward with the reemployment but may require the
24	Employee to provide additional written documentation of the acceptance by reasonable means
25	identified by the Employer within not less than two business days from the acceptance.

1	(d) Rejection. If the Eligible Worker rejects an offer of reemployment or fails to respond to an
2	offer of reemployment within the time prescribed under Section 3300K.5(a)(3), which shall be deemed
3	to be a rejection of the offer of reemployment, the Employer may offer the position to another
4	individual in accordance with Section 3300K.4(c).
5	
6	SEC. 3300K.6. NON-DISCRIMINATION AND DUTY TO REASONABLY ACCOMMODATE
7	ELIGIBLE WORKERS EXPERIENCING A FAMILY CARE HARDSHIP.
8	<u>An Employer shall not discriminate against or take an adverse employment action against an</u>
9	Eligible Worker as a consequence of an Eligible Worker experiencing a Family Care Hardship. An

LEGISLATIVE DIGEST

[Police Code - Right to Reemployment Following Layoff Due to COVID-19 Pandemic]

Ordinance amending the Police Code to create a right to reemployment for certain employees laid-off due to the COVID-19 pandemic if their employer seeks to fill the same position previously held by the laid-off employee, or a substantially similar position, and to reasonably accommodate employees who cannot work because of a family care hardship.

Existing Law

In general, under existing law, there is no right to reemployment for employees working in San Francisco in the event that their employer separates them from employment. However, an emergency ordinance (Ordinance No. 104-20) temporarily requires certain employers operating in San Francisco to offer reemployment to eligible employees laid off as a result of the COVID-19 public health emergency.

The emergency ordinance applies to employers that operate in San Francisco and employ 100 or more employees, except healthcare operations. The emergency ordinance applies to employees who were employed for at least 90 days of the calendar year preceding the notice of a layoff and who suffered layoff due to the emergency. A layoff is a separation from employment of 10 or more eligible employees within a 30-day period, starting on or after February 25, 2020, due to the emergency. If an employer seeks to rehire employees to the same or similar positions previously held by laid-off eligible employees, an employer shall offer reemployment to such eligible employees in order of seniority.

Under the emergency ordinance, the Office of Economic and Workforce Development (OEWD) receives notices of layoffs and offers of reemployment and operates a hotline for workers. The Office of Labor Standards Enforcement (OLSE) is authorized to issue regulations.

Additionally, the emergency ordinance requires employers to reasonably accommodate employees who cannot work because of a family care hardship. A family care hardship is a circumstance in which the employee is unable to work due to any reason for which a person may use paid sick leave under Administrative Code § 12W.4(a) to provide care for someone other than themselves , including but not limited to a need to care for a child whose school or place of care has been closed or whose childcare provider is unavailable as a result of the public health emergency and no other suitable person is available to care for the child during the period of such leave.

The emergency ordinance was enacted on July 3, 2020. Under Charter section 2.107, it will remain in effect for 60 days, unless reenacted.

Amendments to Current Law

This ordinance extends and codifies the emergency ordinance, with clarifications and minor amendments. The substantive provisions of the ordinance are similar to the emergency ordinance, but the ordinance streamlines the process for making and accepting offers of reemployment, corrects an error in the definition of eligible worker to clarify that the worker must have been employed for at least 90 days prior to the notice of layoff without regard to the calendar year, and transfers the authority to issue regulations from OLSE to OEWD. It sunsets one year from the effective date of the emergency ordinance, or on the date on which the public health emergency terminates, whichever date occurs latest.
